(a): The details of proposals received from State Governments for Information Technology Investment Regions(ITIR) along with status are:

(b) and (c): No Sir. Proposal from Government of Telangana for ITIR has not been received. However, Government of Telangana is implementing ITIR at Hyderabad which was notified on 13.11.2013 before creation of State of Telangana.

(d): For implementation of the ITIR in Hyderabad, Ministry of Electronics & Information Technology, Government of India have written letters to Ministry of Road Transport & Highways and Chairman Railway Board for implementing the projects of Central Government, as notified for ITIR Hyderabad. Also, the Hyderabad Metropolitan Development Authority (HMDA) has prepared a Feasibility Report for upgradation of Radial Road from Moosapet to BHEL Junction in Hyderabad and submitted it to Ministry of Road Transport and Highways.
