SCHEME FOR INTEGRATED TEXTILE PARKS

3094. SHRI ANIL SHIROLE:

Will the Minister of TEXTILES वस्त्रमंत्री
be pleased to state:

- (a) the aims and objectives of the Scheme for Integrated Textile Parks (SITP) along with its funding pattern;
- (b) the details of the sanctioned textile parks under SITP in the country, State-wise;
- (c) whether the Government proposes to set up some new textile parks in the country including Maharashtra and if so, the State-wise details thereof along with the funds allocated/facilities to be provided by the Government for these parks and the time by which the said parks are likely to be set up;
- (d) whether the Government has received any proposal from the State Governments to set up textile parks in their States and if so, the details thereof and the response of the Government thereto, proposal-wise; and
- (e) the employment likely to be generated through these parks along with the types of products manufactured in these parks?

(a) & (b): The objective of the Scheme for Integrated Textile Parks (SITP) is to address infrastructure constraints of the textile industry on a cluster basis. Government of India provides support up to 40% of the project cost subject to a ceiling of Rs. 40 crore for development of common infrastructure and common facilities. Funds are released to the Special Purpose Vehicle (SPV) set up for the project. State wise list of textile parks under implementation is at **Annexure I**.

(c): SITP is an industry driven scheme under which parks are set up by entrepreneurs who form SPVs. Funding under the scheme is made to the SPV. The list of textile parks sanctioned in last two years including parks sanctioned in Maharashtra and funds allocated to them is at **Annexure II**. These parks are required to be completed within three years of date of first release of Government grant.

(d): Requests have been received from the State Governments of Orissa and Karnataka for setting up Textile Parks. State Governments/IDCs are requested to mobilize investors/entrepreneurs as per scheme guidelines.

(e): Employment likely to be generated through these parks is approximately 4 lakh . Products manufactured in the parks include yarn, fabric, garments and made-ups.
