Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) the names of the projects declared as National Projects along with their current status, Statewise;
- (b) the system established by the Government for monitoring the progress of work of National Projects;
- (c) whether the Government proposes to declare some more projects including mega irrigation projects as National Projects, if so, the details thereof;
- (d) whether the Government has received any requests from certain States with regard to declaring new national projects; and
- (e) if so, the details thereof and the action taken thereon?

ANSWER

THE MINISTER OF STATE FOR WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (DR. SANJEEV KUMAR BALYAN)

- (a) Sixteen (16) Projects have been declared as National Project. State and Project-wise status of these projects is at **Annexure.**
- (b) The progress of work of National Project is monitored by Central Water Commission (CWC). A High Powered Steering Committee headed by Secretary (MoWR, RD & GR) also reviews the implementation of National Projects.
- (c) to (e) as per information available, Seventeen more project proposals have been received for inclusion under the scheme of National Projects. However, these proposals were not in the prescribed format, or did not qualify to be included under the scheme of National Project as per the guidelines. Some of these projects were later proposed for funding from other agencies
