**3237SHRI VIRENDER KASHYAP:**

Will the Minister of FINANCE be pleased to state:

- (a) the number of employees working in Industrial Finance Corporation of India (IFCI) as on date including Scheduled Castes/Scheduled Tribes (SCs/STs), category-wise;
- (b) whether the IFCI followed the reservation policy for filling up the backlog vacancies of SCs/STs and if so, the details thereof along with the status of backlog vacancies in IFCI, category-wise; and
- (c) the steps taken/being taken by the Government to fill up the said vacancies in this regard?

**ANSWER**

- (a& b) The number of employees working in Industrial Finance Corporation of India (IFCI) as on date including Scheduled Castes/Scheduled Tribes (SCs/STs) is 257 against sanctioned strength of 383(excluding CEO & MD and DMD). IFCI became a Government of India Undertaking (GoI) w.e.f. April 07, 2015. However, in terms of the approval of its Board of Directors in the meeting held on January 06, 2014, IFCI is following GoI guidelines on reservations in recruitments. The last recruitment was held in 2014-15 by following the reservations for SC/ST/OBC. Category-wise details of working employees and backlog vacancies at **Annexure**.
- (c) The IFCI has issued advertisement in June, 2016 for recruitment for the year 2016 including backlog vacancies.
