#### LINKING OF FCI DEPOTS

333. SHRI G. HARI:

SHRI A. ARUNMOZHITHEVAN:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) the number of godowns owned by Food Corporation of India and other Union and State Government agencies, State-wise;
- (b) whether the Government is considering any proposal to link the depots of FCI online through an online network to bring transparency, real time tracking of movement of foodgrains and to minimise storage losses and if so, the details thereof indicating the number of godowns linked so far; and
- (c) whether the FCI has held any discussion with the State Governments in this regard and if so, the outcome thereof?

#### ANSWER

### MINISTER OF CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI RAM VILAS PASWAN)

- (a): As on 31.05.2016, 1885 godowns were available with Food Corporation of India (FCI), out of which 536 godowns are owned by FCI and 1349 godowns are hired from Central Warehousing Corporation (CWC), State Warehousing Corporation (SWC), State Govt. / agencies and private parties. State wise and agency wise details are at Annexure-I.
- (b): FCI is implementing a project called "Depot Online System" to automate all the operations at the depot level and link them via online network. This project will cover all Depots of FCI. As on 11.07.2016, the system has been made operational at 327 Depots of FCI.
- (c): State Governments have been requested to adopt the project and the software developed by FCI. Discussions have also been held with the State Governments of Punjab, Haryana, Rajasthan & Uttar Pradesh.
