SCHOLARSHIP SCHEMES FOR TRIBAL STUDENTS

3595. SHRI KANTI LAL BHURIA:

PROF. CHINTAMANI MALVIYA:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the details of scholarship schemes being implemented by the Government for facilitating education of tribal students in country;
- (b) the details of funds sanctioned released and utilized thereunder during each of the last three years and the current year, State/UT-wise;
- (c) whether the Government proposes to enhance the scholarship amount being provided under these schemes and if so, the details thereof;
- (d) whether the Government has received proposals from various States including Madhya Pradesh for release of funds under the pre/post matric scholarship/vocational schemes; and
- (e) if so, the details thereof, State/UT-wise along with the steps being taken by the Government to ensure timely release of funds to the States under these schemes?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF TRIBAL AFFAIRS

(a) This Ministry implements following scholarship schemes for facilitating education of tribal students in the country:

- (i) Post Matric Scholarship for ST students.
- (ii) Pre Matric Scholarship for ST students studying in classes IX & X.
- (iii) National Overseas scholarship for ST students.
- (iv) Top Class Education for ST students
- (v) Rajiv Gandhi National Fellowship for ST students

Details of the above said schemes are available at **Annexure I**.

(b) The details of funds sanctioned released and utilised under scholarship schemes being implemented by the Government for facilitating education of tribal students is available at **Annexure II**.

(c) No Madam, there is no such proposal to enhance the scholarship amount being provided under above said schemes.

(d) & (e): Government has decided to release scholarship for 2016-17 under centrally sponsored scheme of Post-Matric Scholarship for ST students and Pre-Matric Scholarship for ST students directly in to bank accounts of ST students through Direct Benefit Transfer (DBT) and National Scholarship Portal (NSP) 2.0.

Annexure referred to in reply to part (a) of Lok Sabha Unstarred Question No.3595 for answer on 08.08.2016 tabled by SHRI KANTI LAL BHURIA: PROF. CHINTAMANI MALVIYA: regarding "Scholarship Schemes for Tribal Students".

- i. **Pre Matric Scholarship Scheme for ST students:** This scholarship is given to scheduled tribe students studying in class IX and X. This Scheme covers all ST students whose parent's annual income is below Rs. 2 Lacs. Scholarship of Rs. 150 per month for day scholars and Rs. 350 per month for hostellers are given for a period of 10 months in a year.
- ii. **Post Matric Scholarship Scheme:** This scheme is open to all ST students and is given to enable them to pursue higher studies at Post Matriculation level including technical and professional studies. This Scheme covers all ST students whose parents' annual income is below Rs. 2,50,000/-. Compulsory fees charged by the educational institutions are reimbursed and scholarship amount of Rs. 230 per month to Rs. 1200 per month are given depending on the courses of study.
- iii. **National Overseas Scholarship:** This scheme provides financial assistance to selected students to pursue Post Graduation, PhD and Post Doctoral study abroad. There are 17 awards for scheduled tribe students and 3 awards for students belonging to Particularly Vulnerable Tribal Groups. The selected students are given tuition and other educational fees charged by the foreign universities, maintenance and other grants along with travel expenses. This fellowship is given to the students whose total annual income along with the income of the parents doesn't exceed Rs. 6 Lacs.
- iv. **Scheme of Top Class Education for ST students:** This scholarship is given to ST students for pursuing studies and degree at Post Graduate level in any of the 158 identified institutions of excellence such as IITs, NIITs, IIMs etc. Scholarships are given every year to meritorious students whose family income doesn't exceed Rs. 4.5 Lacs per year. Scholarship amount includes tuition fees, living expenses and allowances for books and computer etc.
- v. **Rajiv Gandhi National Fellowship Scheme for ST students:** Under this scheme 750 fellowships are provided to the ST students each year for pursuing higher studies in India for MPhil and PhD. Fellowship amount is as per UGC norms for a period of 2 to 5 years.
