- (b) the details of increase in the price of natural gas during the above period and subsidy given by the Government to the domestic consumers;
- (c) whether high administrative costs/ inventory losses by downstream companies have taken away the benefits accruing from fall in the prices of crude oil and if so, the details thereof and the reaction of the Government thereto along with the corrective measures taken/being taken by the Government in this regard; and
- (d) whether the Government proposes to set up a committee for ensuring proper distribution of kerosene in the country and if so, the details thereof?

(a): The company-wise details of under-recovery/subsidy incurred on the sale of PDS Kerosene and Subsidized Domestic LPG (including DBTL) by the Public Sector Oil Marketing Companies (OMCs) and the burden sharing of under-recoveries on the sale of Diesel (up to 18.10.2014), PDS Kerosene and Subsidized Domestic LPG (including DBTL) during the last three years and the current year (1<sup>st</sup> Quarter) are given in **Annexure.**

(c): The Public Sector Oil Marketing Companies (OMCs) purchase crude oil based on the price in the international markets. The price of finished products in India is linked to their price in the international markets. The spread (crack margin) between the price of crude oil and petroleum products is linked to the gross profits of refineries. The overall profitability position of oil PSUs depends upon various other general and specific factors including inventory losses. The Profit After Tax (PAT) of Public Sector Oil Marketing Companies (OMCs) during the last three years is given below:
