- (a) the recommendations/suggestions made by the Joint Review Mission on the implementation of Sarva Shiksha Abhiyan in Karnataka;
- (b) whether the Government has taken any measures to implement the said recommendations/suggestions and if so, the details thereof; and
- (c) if not, the reasons therefor?

ANSWER MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI PRAKASH JAVADEKAR)

(a) to (c): The implementation of the Sarva Shiksha Abhiyan (SSA) programme is reviewed twice every year by the Joint Review Mission (JRM) mechanism comprising independent experts and members of external funding agencies, covering different States by rotation. The last JRM visited Karnataka State from $3^{rd} - 8^{th}$ December, 2015. The recommendations of JRM and action taken by the State Govt. of Karnataka are annexed.
