- (a) the number of incidents of fire accidents in Matunga carriage and wagon workshop, Mumbai during the last three years and the current year along with the reasons therefor;
- (b) the number of people injured and/or dead in such incidents;
- (c) the value of the railway property lost in these incidents; and
- (d) the steps taken to prevent incidents of fire accidents in the said workshop?

(a) to (c) The year wise number of fire accidents in Matunga Carriage Workshop, Mumbai, during the last three years and current year upto July, 2016, reasons therefor and the value of railway property lost in these incidents are as under:

No person was injured and/or died in any of these incidents.

- (d) The following steps have been taken to prevent incidents of fire accidents:
  - 1. Different kinds of fire extinguishers, as per requirement, have been provided at the workshop.
  - 2. A Housekeeping Section has been set up in the workshop. Waste products are being collected and disposed off at regular intervals.
  - 3. Boards displaying names of staff trained in Fire Fighting and First-Aid as well as emergency contact numbers have been displayed in different locations of the workshop.
  - 4. The newly inducted employees are being imparted training for fire fighting and First Aid at the Basic Training Centre, Matunga.
  - 5. A basic six day civil defence course is being conducted at Matunga Workshop every year, which includes training for dealing with exigencies at workplace, including fire accidents.
  - 6. The workshop is certified under OHSAS 18001 for occupational health and safety of its personnel.
  - 7. Personnel protection equipment, as prescribed, is provided to the staff to prevent injury.
