4069. SHRI BHARTRUHARI MAHTAB:

SHRI RAHUL SHEWALE:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the private sector has set up more Industrial Training Institutes (ITIs) as compared to the Government in the country during each of the last three years and the current year;
- (b) if so, the details thereof and the reasons therefor along with the number of ITIs functioning in the country, as on date, State/UT-wise;
- (c) whether the quality of education/ training being provided by the ITIs of private and Government sectors is monitored by the Government in the country and if so, the details thereof and if not, the reasons therefor;
- (d) whether the Government has received complaints of inadequate infrastructure and inappropriate/obsolete courses being provided/offered by the ITIs of both private and Government sectors in the country during the said period;
- (e) if so, the details thereof, State/UT-wise and the reasons therefor along with the action taken/being taken by the Government on such complaints so far; and
- (f) the other steps taken/being taken by the Government to improve the functioning of the ITIs across the country?

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

- (a) Yes, It is fact that more private Industrial Training Institutes (ITIs) as compared to the Government has been set up during last three years & current year. Number of private ITIs set up during the last three years are 402, 1213 & 1124 respectively. Process for current year is likely to be finished by 28.08.2016.
- (b) At present, as per data available on NCVT MIS portal, a total number of 12,341 ITIs (Government 2,048 & Private 10,293) are admitting trainees in the affiliated trade/units of National Council for Vocational Training (NCVT) in the Country. Details are at **Annex-I.**
- (c) & (f) DGT, Ministry of Skill Development and Entrepreneurship has taken following initiatives to monitor the quality & performance of ITIs:
 - ✓ Quality improvement tool ISO 29990, Effective utilization of NCVT MIS Portal.
 - ✓ Participation of representative of respective State Govt. in the inspections.
 - ✓ For the new institutes, limit on minimum trades and maximum units etc.
 - ✓ Initiative for good ambience of ITIs, Information Technology lab for all ITIs.
 - ✓ Craftsmen Instructors Training certificate to be mandatory for ITI instructors.
 - ✓ Accreditation process of ITIs through online web portal.
- (d) & (e) Affiliation/De-affiliation of ITIs is regular process. During last 03 years, a total of 180 ITIs have been de-affiliated on the basis of complaints and recommendation of respective States. State-wise details are at **Annex-II**.
