Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) the details of irrigation projects sanctioned in the country especially Odisha so far, locationwise and the areas likely to be benefitted thereform;
- (b) the reasons for delay in the said projects;
- (c) whether any review has been done regarding delay in the said projects;
- (d) if so, the details and the outcome thereof; and
- (e) the follow up action taken by the Government in this regard?

ANSWER

THE MINISTER OF STATE FOR WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (Dr. SANJEEV KUMAR BALYAN)

(a) to (e) Works related to water resources development & management are planned, funded, executed and maintained by the State Governments themselves as per their own resources and priorities. In order to supplement the efforts of the State Governments, Government of India provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through various schemes and programmes such as Accelerated Irrigation Benefits Programme (AIBP) etc.

Presently there are 149 ongoing projects under AIBP. The general reasons for delay in implementation of the Major/medium Irrigation Projects as reported by the State Governments, inter-alia, include paucity of funds, delay in land acquisition, delay in clearances from various agencies, contractual litigation etc. A committee was constituted under Chairmanship of Hon'ble Minister, Water Resources (Chhattisgarh) to look into issues related to PMKSY and completion of these projects. The committee in consultation with States has prioritised 99 projects (including phases) for completion in a time bound manner, out of which 8 projects are of Odisha. The details of these projects including target date of completion are given at **Annexure**. Further to complete these projects in a mission mode, innovative funding mechanisms through NABARD have been approved.
