### **SLUMS NEAR GOVERNMENT COLONIES**

No. 487 SHRI KAUSHAL KISHORE:

Will the Minister OF URBAN DEVELOPMENT be pleased to state:

- (a) Whether a large number of slums have come up around/nearby the Government colonies in Delhi;
- (b) if so, the details of such colonies;
- (c) whether any efforts were made to remove these slums and if so, the expenses incurred;
- (d) the reasons for the existence of such slums despite efforts made to remove them; and
- (e) the further steps taken/being taken by the Government in this regard?

### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (RAO INDERJIT SINGH)

(a) to (e): Yes, Madam. The details provided by the Central Public Works Department (CPWD) are Annexed. CPWD has informed that continuous efforts are made to remove these slums for their relocation and rehabilitation with the help of Delhi Urban Shelter Improvement Board (DUSIB), a body under the Government of National Capital Territory of Delhi (GNCTD). CPWD has informed that these slums have come up over a long period of time, as the appurtenant land was lying unprotected.

Further, the National Capital Territory of Delhi Laws (Special Provisions) Second (Amendment) Act, 2014, provides protection from punitive action till 31 December 2017, inter-alia, with respect to (i) Encroachment or unauthorized development as on 1<sup>st</sup> January 2006; and (ii) Unauthorized colonies, village abadi area (including urban villages) and their extensions, which existed on 31<sup>st</sup> March, 2002 and where construction took place even beyond that date and upto 1<sup>st</sup> June, 2014.
