†505. SHRI R. DHRUVA NARAYANA:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the number of total States' employment scheme launched so far under skill development scheme started by Central Government;
- (b) whether the Central Government has conducted a survey of those organisations who have participated in the skill development scheme;
- (c) if so, whether State-wise details of these have been obtained; and
- (d) if so, the amount distributed among the organisations under skill development scheme so far, State-wise?

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

(a) to (d) The Government has set up National Skill Development Corporation (NSDC) as a Public private Partnership entity to promote private training providers across the Country. The NSDC conducts short term skill training courses through its approved training partners. As on date, it has 267 approved training partners (TPs) with 5093 operational training centres, including 602 mobile centres with coverage across 29 states and 6 Union Territories. All these training partners are approved by the NSDC after following due process. Various kinds of training, including Pradhan Mantri Kaushal Vikas Yojana (PMKVY) are imparted by these TPs based on the Qualifications Packs (QPs) and National Occupation Standards (NOSs) developed by the respective Sector Skill Councils. Field inspections including affiliation & accreditation of these training partners are done by the NDSC. So far, an amount of Rs. 2366 crore has been spent by the NSDC for various training programmes.

Long term vocational training is imparted through Industrial Training Institutes (ITIs). There are a total 13,105 ITIs (Government – 2293 and private - 10812) across India with 18.7 lakh seats in 126 trades. There is no central financial support for these long term courses. The survey of these institutions is done at the time of affiliation through the Quality Council of India.

Further, under Skill Development Initiative (SDI) Scheme, vocational training was provided to people to develop skilled manpower for the industry through a network of 13184 Vocational Training Providers (VTPs). These VTPs are registered through States/UTs and at the end of training, candidates are assessed by the Assessing Bodies empanelled by the Directorate General of Training. Regional Directorates of Apprenticeship Training (RDATs) conduct inspection of these VTPs. There is no fee for training and assessment. Successful candidates are awarded National Council of Vocational Training (NCVT) certificate. The funds for these training courses are released to State/UT Governments for payment towards all reimbursement claims of VTP. A Statement showing the State-wise release of funds under SDI till 2015-16 is annexed (Annexure I).
