GRANT-IN-AID TO CANCER HOSPITALS

Will the PRIME MINISTER be pleased to state:

- (a) whether Atomic Energy Department provides grant-in-aid to various cancer hospitals and research centres in the country;
- (b) if so, the details thereof;
- (c) the amount of grant-in-aid provided to various hospitals/research centres during the last three years and the current year, year-wise;
- (d) whether Atomic Energy Department provide grant-in-aid to various universities/colleges/institutes for the purpose of conducting research in cancer; and
- (e) if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR, PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS
AND PRIME MINISTER'S OFFICE (DR. JITENDRA SINGH):

- (a) Yes, Sir.
- (b) Tata Memorial Centre is an aided institution of the Department of Atomic Energy (DAE). The Department is releasing plan and non-plan grant to the institution. TMC is a comprehensive cancer care centre with a mission of Education, Service and Research. TMC comprises Tata Memorial Hospital and Advanced Centre for Treatment, Research and Education in Cancer (ACTREC). In addition, the Department of Atomic Energy is supporting a comprehensive programme on research and treatment of cancer in India. In order to provide better health facilities to common man, DAE provides financial assistance to Cancer Institutions in India for buying equipment and/or carrying research projects. The applications are scrutinized by the Apex Committee for the Development of Programme of Cancer Institutions in India by DAE for financial assistance for purchase of cancer equipment and research projects under this programme.
- (c) The details of funds released during the 2013-14, 2014-15 and 2015-16 is given in Annexure.-I.
- (d) The Department of Atomic Energy does not provide grant-in-aid to various universities/colleges/institutes for the purpose of conducting research in cancer.
