Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state?

- (a) Whether the Government has sought views of various States including Madhya Pradesh on National Skill Development Policy;
- (b) if so, the details thereof;
- (c) whether training programmes have been conducted for skill development of the youth of minority communities;
- (d) if so, the details thereof; and
- (e) the State-wise details of the ratio of women and men trained under the said programmes?

(a) to (b) The draft policy on Skill Development and Entrepreneurship was circulated to all State Governments/Union Territories (UTs) for their comments/suggestions. Further, a National Workshop of State Ministers on Skill Development and Entrepreneurship Policy was held on 9th May, 2015 in which the Minister of State (Independent Charge) for Skill Development and Entrepreneurship had also urged the States to give their inputs/suggestions on the draft National Policy for Skill Development and Entrepreneurship, 2015. Besides this, draft policy was also put up on MyGov web portal i.e. www.mygov.in for comments/suggestions of various stakeholders. The Policy was finalized based upon various inputs received from different stakeholders including State Governments. The Government has notified the National Policy for Skill Development and Entrepreneurship, 2015 on 15th July, 2015.

The vision of the policy is to create an ecosystem of empowerment by skilling on a large scale at speed with high standards and to promote a culture of innovation-based entrepreneurship which can generate wealth and employment so as to ensure sustainable livelihoods for all citizens of the Country. Equity is also a focus of the Policy, which targets skilling opportunities for socially/ geographically marginalised and disadvantaged groups. The Policy seeks to bridge existing skill gaps, promote industry engagement, operationalise a quality assurance framework, leverage technology and promote greater opportunities for apprenticeship training.

(c) to (e) Government had launched a flagship scheme namely Pradhan Mantri Kaushal Vikas Yojana (PMKVY), on 15th July, 2015 under which skill training was imparted across the Country. Under the scheme, 19.67 lakh persons (Male- 1111136 and Female- 858539) have been trained. State-wise Men and Women trained under PMKVY is at **Annexure-I**. Details of minority candidates trained under the PMKVY Scheme are given below:-

After successful completion of the PMKVY 2015, the Government has launched the PMKVY 2016-20 on 15th July, 2106 with an objective to encourage and promote skill development for the youth throughout the Country by aligning itself with the Common Norms guidelines. The Scheme aims to benefit 10 million youth over the period of four years (2016-2020).

In addition, vocational training is imparted through 13,105 Industrial Training Institutes (ITIs) (Government -2,293 and Private -10,812) in 126 trades including carpenter, electrician, plumber, etc. across the Country. Skill Training for the job roles for rural youth is also being imparted through over 40 skill development programmes/schemes being run by 18 Central Ministries/Departments.

Furthermore, under the Vocational training Improvement Project (VTIP) assisted by the World Bank, 60 ITIs out of 400 ITIs upgraded are located in the Minority Concentrated Districts (MCDs) in 19 States of the Country. A state wise detail for enrolment in 60 ITIs covered under VTIP is at **Annexure II**.

In addition to above, there are 1565 ITIs are located in Minority Concentrated Districts (MCDs) of the country. Out of these 34 ITIs (Govt.+Pvt.) are located in Minority Concentrated Districts (MCDs) of Madhya Pradesh.
