FUNDS UNDER RURAL SCHEMES

700. SHRI SADASHIV LOKHANDE:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) the scheme-wise details of the funds allocated, released and spent to various districts of Maharashtra for different rural development schemes during each of the last three years and the current year; and
- (b) the scheme-wise details of funds allocated, released and utilized by the NonGovernmental Organisations (NGOs) in Maharashtra with special reference to backward areas?

ANSWER

(a) : The Department of Rural Development, inter alia, is implementing Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Deendayal Antyodaya Yojana - National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY), Pradhan Mantri Awaas Yojana –Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY) and National Social Assistance Programme (NSAP) to bring about overall improvement in the quality of life of the people in rural areas through employment generation, skilling of youths, provision of social assistance and other basic amenities. The state-wise funds allocated, released and expenditure incurred under major rural development schemes in various districts of Maharashtra are given at **Annexure**.

(b) : DAY-NRLM aims to ensure that at least one woman member from each poor rural household is brought under self help groups by 2024-2025. Funds are released to the States under the Programme. Mahila Kisan Sashaktikaran Pariyojana (MKSP) is a sub component of Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM). Under MKSP, during the year 2011-12 a project with total cost of Rs. 5.8 crore was approved for empowerment of women farmers. The coverage area of the project is Wardha and Yavatmal districts of Maharashtra. The central share is Rs. 4.37 crore out of which Rs. 3.2 crore has been released .The project is being implemented by MS Swaminathan Research Foundation. DDU-GKY is a demand driven placement-linked skilling scheme which is implemented in a PPP mode with Project Implementing Agency (PIA) registered with Ministry of Rural Development.

DDU-GKY is being implemented by the Maharashtra State Livelihoods Mission (MSRLM). MSRLM has sanctioned 30 projects in the state at a cost of Rs. 122.70 crores for skilling of 39,332 candidates in Maharashtra. It has released Rs. 29.88 crores to PIAs so far.
