Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) the total budget allocated under Accelerated Irrigation Benefit Programme (AIBP) for the last three years including the current year;
- (b) whether the Government proposes to undertake a credible, independent review of AIBP to assess the reasons for pendency of the irrigation projects for so long, if so, the details thereof;
- (c) whether large dams are built under AIBP without thinking of feasibility or water availability, if so, the details thereof;
- (d) whether the Government has approved irrigation projects worth Rs. 17000 crores during the current financial year and prioritized 46 AIBP projects in the Budget for the years 2016-17;
- (e) if so, the details of projects undertaken, State/UT-wise; and
- (f) the number of projects completed out of the sanctioned projects and the number of projects pending in each of the States particularly Karnataka and West Bengal?

(a) Budget allocated under Accelerated Irrigation Benefit Programme(AIBP) for the last three years including the current year is as follows:

- **(b)** Programme Evaluation Organization of erstwhile Planning Commission carried out evaluation study on AIBP, in 2010 November. It is mentioned in their report that the main reasons behind the non-completion of the designed irrigation potential are:
 - Problems in land acquisition.
 - Law and order problems particularly in North-Eastern States.
 - Lack of coordinating among different department of States Government etc.

- (d) & (e) No new project has been included under AIBP during current financial year. Ninety Nine (99) projects out of 149 ongoing AIBP projects have been prioritized in consultation with States, for completion up to December, 2019. Out of these priority projects 23 projects are planned for completion by March, 2017. Details of these 99 Projects as intimated by State Government are at Annex-I.
- (f)Under AIBP, 143 projects have been completed out of 297 sanctioned projects. Five projects were foreclosed and 149 Projects are ongoing in the various states. Details are given at **Annex-II.**
