PART-I

CHAPTER-I

OVERVIEW OF DEPARTMENT OF AGRICULTURE AND FARMERS WELFARE

1.1 India is a global agricultural powerhouse and agriculture continues to be the prime pulse of Indian economy. Agriculture with its allied sectors, is the undisputed largest livelihood provider in India **as** 54.6 % of the total workforce is engaged in Agriculture and Allied Sector Activities (Census 2011) and accounted for 18.6% (First Advance Estimates) of the nation's Gross Value Added (GVA) at current prices during 2021-22. The overall economy and growth in other sectors hinges on the performance of agriculture to a considerable extent through its backward and forward linkages. Given the significant role played by Agriculture in rural livelihood, employment generation and food security of the country, Government of India has taken several major steps for the development & transformation of Agriculture sector in the Country in a sustainable manner.

1.2 The Central government has taken initiatives such as PM KISAN to provide income support to farmers, crop insurance is being assured through Pradhan Mantri Fasal Bima Yojana, irrigation facilities are ensured under Pradhan Mantri Krishi Sinchai Yojana, easy access to institutional credit is being provided through Kisan Credit Card and various other channels, Bio-input Resource Centres are being established to make Natural farming a mass movement, FPOs are being constituted to help Small and Medium Farmers avail the benefit of govt. schemes related to agriculture, Agriculture Accelerator Fund to remove supply chain bottlenecks, creation of Digital Public Infrastructure in Agriculture & the focus on Artificial Intelligence to boost availability of information for better crop management including post harvest activities and the e-NAM initiative is being promoted in a big way to help farmers get more remunerative prices for their produce.

Department of Agriculture and Farmers Welfare (DA&FW) and its Mandate

Land Use Statistics

1.5 As per the Land Use Statistics 2018-19, the total geographical area of the country is 328.7 million hectares, of which 139.3 million hectares is the reported net sown area and 197.3 million hectares is the gross cropped area with a cropping intensity of 141.6%. The net area sown works out to be 42.4% of the total geographical area. The net irrigated area is 71.6 million hectares. The details of important parameters of Land Use Statistics for the year 2018-19 are given in the table below:

Rainfall

Monsoon Rainfall (June – September)

1.6 The cumulative rainfall in the country during the monsoon season i.e. 01st June to 30th September, 2022 has been higher by 6% than the Long Period Average (LPA). Rainfall in the four broad geographical divisions of the country during the above period has been higher than LPA by 22% in South Peninsula, by 19% in Central India and by 1% in North-West India but lower than LPA by 18% in East & North East India. Out of 36 Meteorological Sub- divisions, 12 Met Sub-divisions in the country had received large excess/excess rainfall, 18 met subdivisions received normal rainfall and 6 met subdivisions received deficient rainfall. Out of 703 districts for which rainfall data available, 53(7%) Districts received large excess rainfall, 175(25%) districts received excess rainfall, 280(40%) Districts received normal rainfall, 188(27%) districts received deficient rainfall and 7(1%) Districts received large deficient rainfall.

Post-Monsoon (October -December)

1.7 During the Post-monsoon season (1st October to 31st December, 2022) country received rainfall which was 19% higher than the LPA. Out of 36 Meteorological Subdivisions, 16 received large excess/excess rainfall, 14 received normal rainfall and 6 Met Sub-divisions received deficient/large deficient rainfall.

Production Scenario of Food grains during 2021-22

1.8 As per Fourth Advance Estimates for 2021-22, the production of Food grains in the country is estimated at 315.72 Million Tonnes which is higher by 4.98 Million Tonnes than the production of food grain during 2020-21. The production during 2021-22 is higher by 25 Million Tonnes than the previous five years' (2016-17 to 2020-21) average production of food grains. Total production of Rice during 2021-22 is estimated at record 130.29 Million Tonnes. It is higher by 13.85 Million Tonnes than the last five years' average production of 116.44 Million Tonnes. Production of Wheat during 2021-22 is estimated at 106.84 Million Tonnes. It is higher by 2.96 Million Tonnes than the last five years' average wheat production of 103.88 Million Tonnes. Production of Nutri / Coarse Cereals estimated at 50.90 Million Tonnes, which is higher by 4.32 Million Tonnes than the last five years' average production of 46.57 Million Tonnes. Total Pulses production during 2021-22 is estimated at record 27.69 Million Tonnes which is higher by 3.87 Million Tonnes than the last five years' average production of 23.82 Million Tonnes. Total Oilseeds production in the country during 2021-22 is estimated at record 37.70 Million Tonnes which is higher by 1.75 Million Tonnes than the production of 35.95 Million Tonnes during 2020-21. Further, the production of oilseeds during 2021-22 is higher by 5.01 Million Tonnes than the average oilseeds production. Total production of Sugarcane in the country during 2021-22 is estimated at record 431.81 Million Tonnes which is higher by 58.35 Million Tonnes than the average sugarcane production of 373.46 Million Tonnes. Production of Cotton and Jute &

Mesta is estimated at 31.20 Million Bales (each of 170 kg) and 10.32 Million Bales (each of 180 kg), respectively.

Production Scenario during Kharif 2022-23 (as per First Advance Estimates)

1.9 As per First Advance Estimates for 2022-23 (Kharif Only), total foodgrain production in the country estimated at 149.92 million tonnes which is higher by 6.98 million tonnes than the average foodgrain production of previous five years' (2016-17 to 2020-21).

Total production of kharif rice during 2022-23 is estimated at 104.99 million tonnes. It is higher by 4.40 million tonnes than the previous five years' (2016-17 to 2020-21) average Kharif rice production of 100.59 million tonnes.

1.10 Production of Maize in the country during 2022-23 is estimated at record 23.10 million tonnes which is higher by 3.21 million tonnes than the average Maize production of 19.89 million tonnes.

1.11 Production of Kharif nutri / coarse cereals is estimated at 36.56 million tonnes which is higher by 2.92 million tonnes than the average production of 33.64 million tonnes. Total Kharif pulses production during 2022-23 is estimated at 8.37 million tonnes. Total Kharif oilseeds production in the country during 2022- 23 is estimated at 23.57 million tonnes which is higher by 1.74 million tonnes than the average oilseeds production.

1.12 Total Production of sugarcane in the country during 2022-23 is estimated at record 465.05 million tonnes. The production of sugarcane during 2022-23 is higher by 91.59 million tonnes than the average sugarcane production of 373.46 million tonnes.

1.13 Production of cotton is estimated at 34.19 million bales (of 170 kg each) and production of Jute & Mesta is estimated at 10.09 million bales (of 180 kg each).

1.14 The Committee sought to know about the likely production scenario in the Country in regard to i) Food-grains ii) Oilseeds, iii) Sugarcane, iv) Cotton, v) Jute & Mesta during 2023-24 and the next two financial years against the likely domestic demand. In this regard, the Department of Agriculture stated:

"In order to enhance the production of foodgrains, pulses, oilseeds, sugarcane, cotton, jute and mesta, the Department of Agriculture & Farmers Welfare (DA&FW) is implementing Food and Nutrition Security Programme for the promotion of the crops like rice, wheat, pulses, coarse cereals, nutri cereals, cotton, jute & mesta, sugarcane during 2022-23. Assuming normal agro-climatic conditions during 2023-24 and next two years, the production of these crops have been estimated/projected. The demand and supply projection for 2023-24 to 2025-26 is based on the NITI Aayog report 'Demand and Supply Projection Towards 2033 on Crops, Livestock, Fisheries and Agricultural Inputs' for food-grains & pulses. The excess production of cotton, sugar and jute are exported. The projection of demand and production are as under:

Demands for Grants (2023-24) - Demand No.1

1.15 The Detailed Demands for Grants (2023-24) of the Department of Agriculture and Farmers Welfare were presented to Parliament on 13 February, 2023. The Budget Estimates (BE) of Demand No.1 pertaining to the Department of Agriculture and Farmers Welfare for the year 2023-24 is Rs.115531.79 Crore. The Committee have examined, indepth, the Demands for Grants of the Department for the year 2023-24 and these details are given in the succeeding Chapters of the Report. The Observations / Recommendations of the Committee are presented at the end of the Report. The Committee expect the Department of Agriculture and Farmers Welfare to take the Committee's observations / recommendations seriously and act on them expeditiously and furnish action taken replies in respect of the observations / recommendations made in the Report within three months from the date of presentation of this Report.

Summary of Demand for Grants 2023-2024

1.16 Department of Agriculture and Farmers' Welfare has been allocated Rs. 115531.79 Crore for financial year 2023-24 under Demand No. 1. Allocation of funds under different Heads of Accounts along-with actuals for 2021-22, BE & RE for 2022-23, and BE 2023-24 are as under:-

1.17 When asked by the Committee to provide details of the proportion of Budgetary Allocations made in favour of the Department out of the total Budget of the Government of

India during the last three financial years and their comparison with other important Ministries/Departments, the Department has submitted:

"Government of India has taken several steps for the development of agriculture and welfare of the farmers. Emphasis has been laid on promoting agriculture sector through modern technologies to transform agricultural practices, increase productivity and profitability. Govt. is proposing to launch an Atmanirbhar Clean Plant Program to boost availability of disease free, quality planting material for high value horticultural crops. Steps have been taken to improve the income of the farmers. Investment in infrastructure, creation of marketing avenues for farmers, their collectivization, better delivery of credit, risk mitigation through insurance and income support are being prioritized. The Schemes implemented by the Department covers a range of activities in the Agriculture Sector such as income supplementation, risk mitigation in case of Crops losses, short term working capital loans at subvented rates, production and distribution of cereals, pulses and oilseeds and commercial crops, horticultural crops, seed quality, production and distribution, nutrient management, plant quarantine, pest management, agricultural mechanization, micro irrigation, rainfed area development, soil health management, agricultural extension, post harvest technology and management, efficient marketing of agricultural and allied produce and improving information and communication technology in the agriculture sector. As seen in the table below, Agriculture has higher share of total budget of Government vis-a-vis other Departments.

Analysis of Demands for Grants - Demand No.1

1.18 On being asked by the Committee to provide information regarding demand and actual allocations by the Ministry of Finance and the difference between, the two, Schemewise, for the last 3 Financial Years and the current year Demands for Grants, the Department has submitted:-

"Proposed Allocations Schemes-wise, *vis-a-vis* the Actual Allocations provided by the Ministry of Finance and the difference between the two, Schemewise, for the last 3 Financial Years and the current year Demands for Grants may be seen at **Annexure-I**."

1.19 When the Committee asked how the Department will implement its Schemes during 2023-24 with less allocation as compared to 2022-23, the Department has submitted :-

"The Department has been allocated Rs.115531.79 Crore(BE) for financial year 2023-24 under Demand No.1. There will be no shortage of funds for implementation of any schemes of the Department. As per the requirement of the scheme, additional funds may be provided at the RE stage."

1.20 Out of Rs.110254.53 Crore allocated at RE Stage (2022-23) only Rs. 64602.66 Crore (as on 31.01.2023) has been utilized by the Department. When the Committee asked to give the reasons for not utilizing the full allocated funds and the latest information w.r.t. to Actual Utilization during 2022-23, the Department has submitted:

"Out of Rs.110254.53 Crore allocated at RE Stage (2022-23) Rs. 66030.53 Crore (as on 10.2.2023) has been utilized by the Department. The release of funds under the scheme during the initial months of the financial year could not be made as the State Governments were not able to comply with the DoE's instructions for release of funds under Centrally Sponsored Schemes and Central Sector Schemes and Instructions have been issued by Ministry of Finance from time to time to regulate expenditure, specifically at the fag end of the year. Department is releasing funds in accordance of the instructions of the Min. of Finance. However, Department of Economic Affairs, on special request of this Department has relaxed Quarterly Expenditure Plan for last quarter and month of Current Financial Year and also agreed to revalidate savings from earlier quarters for utilization in 4th quarter.

1.21 During the course of evidence, the Secretary of the Department added:

"The budget estimate of our Department for the year 2023-24 is Rs 115531.79 crore. Last year, the agricultural exports touched the figure of 50 billion dollars for the first time. The main focus of the Department is to supplement the income of farmers, implement plans for mitigation of risks being faced by them especially in the present time of Climate Change. Department is working beyond

value chain to ensure that no bottlenecks remain in the system. Crop diversification is also being given prominence and impetus is being given to Digital technology so that farmers are able to get timely information/updates. For the Financial year 2023-24, an allocation of Rs.1,15,531.79 Crore has been done out of which Rs.60000 Crore is for PM-KISAN, Rs.23000 Crore is for Credit Support, Rs.13,625 Crore for Insurance Scheme. Rs.98980.03 Crore is reserved for Central Sector Schemes and Rs.14675.82 Crore is meant for Centrally Sponsored Schemes."

Increase in Farmers' Income

1.30 On the query regarding the schemes being implemented to increase income of farmers apart from enhancement in Credit limit, the Department has submitted:

"Increase in income of farmers is assessed/ estimated on the basis of results of successful implementation of all schemes/programmes of DA&FW. Some of the important schemes/ programmes initiatives pertaining to DA&FW in this regard and achievements therein are stated below:

(1) Unprecedented enhancement in budget allocation

In the year 2013-14 the budget allocation of Ministry of Agriculture (including DARE) and Ministry of Fisheries, Animal Husbandry & Dairying was only 30223.88 crore. This has increased by more than 4.35 time to Rs. 131612.41 crore in 2023-24.

(2) Income support to farmers through PM KISAN

Launch of PM-KISAN in 2019 -an income support scheme providing Rs. 6000 per year in 3 equal installments. More than Rs. 2.24 lakh crore has been released so far to more than 11 crore farmers as of now.

(3) Pradhan Mantri Fasal BimaYojana (PMFBY)

PMFBY was launched in 2016 addressing problems of high premium rates for farmers and reduction in sum insured due to capping. In past 6 Years of implementation – 38 crore farmer applications has been enrolled and over 12.37 crore (Provisional) farmer applicants have received claims. During this period nearly Rs. 25,252 crore were paid by farmers as their share of premium against which claims of over Rs. 1,30,015 crore (Provisional) have been paid to them. Thus for every 100 rupees of premium paid by farmers, they have received about Rs. 514 as claims.

(4) Institutional credit for agriculture sector

i. Increased from Rs. 7.3 lakh crore in 2013-14 with a target to reach Rs. 18.5 lakh crore in 2022-23.

ii. Benefit of concessional institutional credit through KCC at 4% interest per annum has also now been extended to Animal Husbandry and Fisheries farmers for meeting their short-term working capital needs.

iii. A special drive has been undertaken since February 2020 to provide concessional institutional credit with focus on covering all PM-KISAN beneficiaries

through Kisan Credit Cards (KCC). As on 23.12.2022, 387.87 lakh new KCC applications have been sanctioned with a sanctioned credit limit of Rs. 4,49,443 crore as part of the drive.

(5) Fixing of Minimum Support Price (MSP) at one-and-a half times the cost of production –

• Government has increased the MSP for all mandated Kharif, Rabi and other commercial crops with a return of at least 50 per cent over all India weighted average cost of production from 2018-19.

• MSP for Paddy (common) has increased to Rs. 2040 per quintal in 2022-23 from Rs. 1310 per quintal in 2013-14.

• MSP for Wheat increased from Rs. 1400 per quintal in 2013-14 to Rs. 2125 per quintal in 2022-23.

(6) **Promotion of organic farming in the country**

i. Paramparagat Krishi Vikas Yojana (PKVY) was initiated in 2015-16 to promote organicfarming in the country. 32384 clusters have been formed and an area of 6.53 lakh hectare has been covered benefitting 16.19 lakh farmers. In addition, Under NamamiGange Programme 123620 hectare area covered and under natural farming 4.09 lakh hectare area covered. Farmers in Uttar Pradesh, Uttarakhand, Bihar and Jharkhand have taken-up organic farming on either side of the river Ganga to control river water pollution as well as to fetch additional income to farmers.

ii. Government also proposes to promote sustainable natural farming systems through the scheme Bhartiya Prakratik Krishi Padhati (BPKP). The proposed scheme aims at cutting down cost of cultivation, enhancing farmer's income and ensuring resource conservation and, safe and healthy soils, environment and food.

iii. Mission Organic Value Chain Development in North East Region (MOVCDNER)has been launched. 379 Farmer Producer Companies have been formedcomprising of 189039 farmers and covering 172966 hectare area.

(7) Per Drop More Crop

Per Drop More Crop (PDMC) scheme was launched in the year 2015-16 which aims to increase water use efficiency, reducing cost of inputs and increasing productivity at the farm level through Micro Irrigation technologies i.e. drip and sprinkler irrigation systems. So far, an area of 69.55 lakh hectare has been covered under Micro irrigation through the PDMC scheme from the year 2015-16.

(8) Micro Irrigation Fund

A Micro Irrigation Fund of initial corpus Rs 5000 crore has been created with NABARD. In the Budget Announcement for 2021-22, the corpus of the fund has been increased to Rs.10000 Crore. Projects worth Rs 4710.96 crore covering 17.09 lakh hectares have been approved.

(9) **Promotion of Farmer Producer Organisations (FPOs)**

i. A new Central Sector Scheme for Formation & Promotion of new 10,000 FPOs launched by Hon'ble Prime Minister on 29 th February, 2020 with budget outlay of Rs 6865 Crore till 2027-28.

ii. As on 31.12.2022, 4280 FPOs have been registered under new FPO scheme.

iii. Equity Grant of Rs. 53.4 Crore has been released to 1415 FPOs as on 30.11.2022.

iv. As on 12.12.2022, Credit Guarantee Cover worth Rs. 78 Cr. Issued to 447 FPOs.

(10) A National Beekeeping and Honey Mission (NBHM) has been launched in 2020 as part of the Atma Nirbhar Bharat Abhiyan to increase productivity of crops through pollination and increase in honey production as an additional source of income. Rs. 500 crore for the period 2020-2021 to 2022-2023 has been allocated for beekeeping sector. 114 projects for assistance of about Rs. 139.23 Crore, approved/ sanctioned for funding under NBHM during 2020-21 & 2021-22 till date.

(11) Agricultural Mechanization

Agricultural mechanization is an extremely vital to modernize agriculture and reduce drudgery of farming operations. During the period from 2014-15 to March, 2022 an amount of Rs.5490.82 crore have been allocated for agricultural mechanization. 13,88,314 numbers of machines and equipments have been provided to farmers on subsidy basis. 18,824 custom hiring centers, 403 high-tech hubs and 16,791 farm machinery banks have been established to make available agricultural machines and equipments to the farmers on rental basis. During the current year i.e. 2022-23, so far an amount of Rs. 504.43 Crore have been released for distribution of around 65302 machines on subsidy, establishment of 2804 CHCs, 12 Hi-tech hubs and 1260 Village Level Farm Machinery Banks.

(12) Setting up of National Agriculture Market (e-NAM) extension Platform

• 1260 mandis of 22 States and 03 UTs have been integrated to e-NAM platform

• More than 1.75 Crore Farmers & 2.4 Lakh traders have been registered on e-NAM portal.

• Total volume of 7.27 Crore MT & 21.9 Crore numbers (bamboo, betel leaves, coconut, lemon & sweet corn) collectively worth approximately Rs. 2.50 lakh crore of trade has been recorded on e-NAM platform.

• 203 Agriculture and allied products Tradable Parameter have been formulated for Assaying on e-NAM platform

(13) Launch of the Edible Oils – Oil Palm programme has been approved with a total outlay of Rs 11,040 crore. This will bring an additional area of 6.5 lakh hectare under Oil Palm plantation with 3.28 lakh hectare in the north-eastern states and 3.22 lakh hectare in the rest of India in the next 5 years. The major focus of the Mission is to provide Viability Prices of fresh fruit bunches (FFBs) to the farmers linked with assured procurement by industry with a simpler price fixing formula.

(14) Agri Infrastructure Fund (AIF)

Since inception of AIF in the year 2020, the scheme has sanctioned an amount of Rs.14170 crore worth agriculture infrastructure in the country for 19191 projects. With the support of the scheme, various agriculture infrastructures were created and some of the infrastructure are at the final stage of completion. These infrastructures include 8215 warehouses, 3076 primary processing units, 2123 custom hiring centres, 992 sorting & grading units, 728 cold store projects, 163 assaying units and around 3632 other kinds of post-harvest management projects and community farming assets.

(15) Improvement in farm produce logistics, Introduction of Kisan Rail.

Kisan Rail has been launched by Ministry of Railways to exclusively cater to movement of perishable agrihorti commodities. First Kisan Rail was started in July 2020. Till 31st December, 2022, 2359 services on 167 routes have been operated.

(16) Integrated Development of Horticulture - Cluster Development Programme:

The Cluster Development Programme (CDP) is designed to leverage geographical specialization of horticulture clusters and promote integrated and market-led

development of pre-production, production, post-harvest, logistics, branding, and marketing activities. DA&FW has identified 55 horticulture clusters, of which 12 have been selected for the pilot phase of the CDP.

(17) Creation of a Start-up Eco system in agriculture and allied sector

So far, 1102 Startups during FY 2019-20 to 2022-23 have been finally selected by different knowledge partners and agribusiness incubators of DA&FW. A total of Rs. 66.83 crore grants-in-aid has been released for funding to these Startups to the respective Knowledge Partners (KPs) & RKVY RAFTAAR Agri Business Incubator (R-ABIs) as grants-in-aid support by DA&FW.

(18) Achievement in Export of Agri and Allied Agri- Commodities

The country has witnessed emphatic growth in export of agri and allied commodities. As compared to previous year 2020-21, the Agri and allied export has increased from 41.86 billion USD in 2020-21 to 50.24 billion USD in 2021-22 i.e. an increase of 19.99%."

1.31 On being asked by the Committee that the total projected expenditure by the Government in 2023-24 would be Rs. 45.03 lakh crore out of which only about 2.57% or Rs.1.15 lakh Crore is the share of the Department of Agriculture and Farmers Welfare and whether this would be sufficient to implement Schemes aimed at doubling the average annual income of a farmer in the country in near future, the Department submitted as under :-

"Yes. Government of India has allocated Rs. 115531.79 Cr to the Department of Agriculture & Farmers Welfare during FY 2023-24. Agriculture is state subject and State Governments have their own budgetary provision and their schemes/programmes for development and promotion of agriculture and welfare of farmers. The Central Governments initiatives are in support of the efforts of the State Governments. The efforts of Government at positive implementation of these schemes have yielded remarkable results towards augmenting the income of the farmers. As part of the 'Azadi ka Amrit Mahotsav', Indian Council of Agricultural Research (ICAR) has released a book, which contains compilation of success stories of 75,000 farmers out of innumerable successful farmers who have increased their income more than two times.

The Department further submitted that it may be noted that despite significant stress on government finance on account of recovery from pandemic induced shock, global economic scenario, etc, the allocation of the Department is on the higher side as compared many other Departments, in view of Government's priority on Agriculture sector.

Department had proposed an amount of Rs. 155217.34 crore under BE 2023-24 against which Rs. 115531.79 crore has been agreed by the Ministry of Finance. Summary of funds sought by the Department, approved by the Government and actually allocated and utilized during the last three years may be seen as under:

International Year of Millets 2023

1.32 On being asked by the Committee regarding the proposed strategy / roadmap adopted by the Department to ensure the required production-increase and self-sufficiency in respect of crops such as foodgrains, Pulses, Sugarcane, Jute & Mesta in general and coarse cereal including Millets in particular in view of the declaration of 2023 as International Year of Millet, the Department submitted as under :-

"Under the centrally sponsored scheme Food & Nutrition Security Programme – foodgrains & commercial crops, the strategy is to make available new High Yielding Varieties, Hybrids to the farmers in a sustainable manner. For this, the scheme provides incentives for strengthening of seed production chain from breeder seed production, procurement to distribution of certified seeds. The scheme also provides assistance on production and distribution of newly released varieties/hybrids, advance production & protection technologies and its demonstration at farmers' field for expeditious adoption and critical inputs like water saving devices, machinery/implements etc. In addition, it also focus on low productivity and high potential districts including cultivation of foodgrain crops in rainfed area, implementation of cropping system centric interventions,

focus on pulses production through utilization of rice fallow, rice bund and intercropping of pulse with coarse cereals, oilseeds and commercial crops, promotion and extension of improved technologies etc.

The DA&FW also ensures flexibility to the states to undertake crop production programmes under Rashtriya Krishi Vikas Yojana (RKVY). To utilize the rice fallows, the Department is implementing a programme for promotion of pulses in 11 states to utilize the kharif fallow during rabi season besides, promotion of inter-cropping of pulses. The states are also advised to diversify area with excess production to more remunerative alternative crops including horticulture. The production of foodgrains viz., rice, wheat, coarse cum nutri cereals, sugarcane, cotton (except Pulses) is sufficient to meet the domestic demand. The surplus crops production is exported. However, the gap in the domestic demand & supply of pulses are met through imports which is only 10-12% of production.

In view of International Year of Millets, more emphasis is being given on nutri-cereals. It is proposed to implement Nutri-Cereal component under Food & Nutrition Security scheme in all the districts of the country beyond 2022-23, which was being implemented in focused 212 districts of 14 states & flexibility has been given for north-eastern and hilly states until now. The strategy under Food & Nutrition Security -Nutri Cereals is to promote latest crop production and protection technologies, newly released varieties/hybrids at farmers' field through state governments. Further, to encourage the area expansion and production of millets across the country, the State/UTs are supported under the scheme to organize state level workshops, district level millet festivals, road shows, creation of awareness and publicity etc.

The Government is implementing Edible Oil-Oilseeds programme (earlier known as National Food Security Mission-Oilseeds) to augment the availability of vegetable oils and to reduce the import of edible oils by increasing the production and productivity of oilseeds (Groundnut, Soybean, Rapeseed & Mustard, Sunflower, Safflower, Sesame, Niger, Linseed and Castor) and area expansion of Tree Borne Oilseeds (Olive, Mahua, Kokum, Wild Apricot, Neem, Jojoba, Karanja, Simaroba, Tung, Cheura and Jatropha) in the country.

The Government is also implementing a separate Edible Oil-Oilpalm (earlier known as National Food Security Mission-Oilpalm) to promote oil palm cultivation for making the country Aatamnirbhar in edible oils with special focus on North-Eastern States and Andaman and Nicobar Islands. Programme envisages targeting an additional 6.5 lakh hectare area from 2021-22 to 2025-26.

Both Edible Oil-Oilseeds and Edible Oil-Oil palm are being implemented in the country with the objective of augmenting the availability of edible oils by increasing the production and productivity of oilseeds and oil palm and reducing the import burden. Oilseeds programme is being implemented in 28 States/UTs in the Country during 2022-23.

Proposed action plan to enhance production and productivity of oilseeds:

Government has lunched **Edible Oils- Oilseeds** programme with an allocation of Rs 4895 crore (Gol Share) with following objectives.

• To enhance production of edible oils from different sources from 11.57 million tonnes in 2021-22 to 18.57 million tonnes (13.63 million tonnes from primary source and 4.94 million tonnes from secondary source) in 2025-26.

• To produce 54.10 million tonnes of edible oilseeds by 2025-26 from current production of 35.95 million tonnes.

• To increase productivity of edible oilseeds from current 1277 kg/ha to 1674 kg/ha by 2025-26.

• To bring additional oilseeds area under edible oilseeds from current 28.15 million ha to 32.31 million hectare by 2025-26 through Special programmes on Mustard/ Soybean/ Groundnut /Sunflower and minor oilseeds crops in Rice fallow, Intercropping and Non-Traditional States, etc.

• To reduce import dependency from 56% to 36% by 2025-26 with implementation of Oilseeds & Oilpalm programme by 2025-26."

1.33 On being further asked by the Committee regarding the steps being taken to boost the exports of millets thereby enhancing farmers' income and how does the Department plan to bridge the gaps in supply chain of millets be it promoting sustainable production, enhanced nutrition, increased consumption and so on, the Department submitted as under:-

"The Department is implementing Food & Nutrition Security - Nutri Cereals to increase the domestic production of millets through area expansion and productivity

enhancement. Further, to boost the exports of millets, the scheme proposes to implement Nutri Cereals component in all the districts of the country beyond 2022-23. Further, the states/UTs are advised to adopt latest crop production and protection technologies brought out by Indian Council of Agricultural Research (ICAR) and State Agricultural Universities (SAUs) under the scheme.

In addition to above, the Department of Agriculture and Farmers Welfare, to raise awareness for Indian millets in the global market, the DA&FW has participated at various key international events and expos held recently such as Dubai Expo 2022, Saveurs& Métiers Trade Show, Belgium (15-17th January 2023) and Millet Food Festival at Nigeria (28th January 2023). The DA&FW further intends to participate and promote Indian millets at various upcoming international events during 2023 which include Gulfood 2023 (20 - 24th February, 2023), Natural Products Expo, USA (7-11th March 2023), Anufood, Brazil (11 – 13th April, 2023) etc. DA&FW has formed a multi-stakeholder delegation, comprising officials/ representatives from DA&FW, State Agriculture Departments, officials of other Ministries/ Departments, agri-allied bodies such as Small Farmers' Agri-Business Consortium (SFAC), Indian Institute of Millets Research (IIMR), Hyderabad and International Crops Research Institute for the Semi-Arid Tropics (ICRISAT), Hyderabad, millet chefs and millet-based Farmer Producer Organizations (FPOs)/ startups, which is poised to be attending international events to represent India's prowess in the production, productivity and marketing of millets.

Agricultural and Processed Food Products Export Development Authority (APEDA) is specialized agency for promotion of exports supporting DA&FW in its efforts towards making India the 'Global Hub for Millets'. Additionally, Indian Embassies and High Commissions abroad have been allocated dedicated months to conduct activities towards International Year of Millets (IYM) during 2023. The embassies are conducting various engagements involving the international diaspora such as Business-to-Business (B2B) meetings, food festivals, trade shows etc. to promote Indian millets and increase their demand globally.

State Governments have also been allocated specific months during 2023 to engage local communities for creating awareness on millets. State Governments have been organizing large scale events and trade fairs focused on millets which also facilitate B2B linkages, knowledge-building workshops and training sessions, exhibitions by millet-based startups and FPOs, etc. The initiatives such as above are being implemented to boost exports of millets and further enhance farmers income. These will also help to bridge the gaps in supply chain of millets and increase both production and consumption of millets in the country."

SCHEDULED CASTES SUB-PLAN

1.34 On being asked by the Committee that the Government has made provision for earmarking specific funds for implementation of Scheduled Castes Sub Plan (SCSP) under different Schemes / Programmes and to furnish financial performance of SCSP under various Schemes being implemented during the last three financial years, the Department submitted as under:-

Reasons for Shortfall/ Excess:

1.35 There is a time lag between the release of funds from Gol to State Governments and from State Finance Department to State Agriculture Department as a result of which implementation and utilization of fund were delayed. Further, proposals from States are also not received in commensurate with allocation under SCSP availability of SC beneficiaries

• Savings was due to less demand from the State Governments owing to adverse impact of COVID-19 pandemic and imposition of lockdown in the States. State Finance Departments were not able to release and corresponding State Share to the Implementing Agencies in time as FY 2020-21 was a challenging year from the revenue point of view.

• The pace of release/utilization of funds, during 2021-22, under the Centrally Sponsored Component being implemented through States/UTs, was very slow owing to teething issue in implementation of Guidelines of new procedure for release of funds adopted as per the directions of Ministry of Finance. The States had taken considerable time in fulfilling the stipulations/requirements laid down under the new procedure.

• The State Government had huge unspent balance with them in SNA account as well as in State treasury and were not able to comply with Dept. of Expenditure's SNA guidelines for new procedure of fund release. SNA mapping on PFMS portal for many states were also incomplete and various checklist, undertaking etc were not furnished by States/UTs in time. Therefore, funds were not released to many States/UTs.

(i) States have been impressed upon to ensure full utilization of funds based on realistic plans and identification of SC/ST beneficiaries in time

(ii) States are being sensitized from time to time to complete the documentation and audit of their accounts so that the Ministry may release the funds in a timely manner. (iii) The meetings between stakeholders are held frequently so as to clear project based proposals from time to time.

(iv) The State Governments are advised to ensure that the implementation schemes is not impeded for any delay in transfer of funds (GOI share and State Share) from treasury to Implementing Agencies/States SNA Accounts.

(v) The Implementing Agencies are impressed upon to pre plan the activities as well as the funds requirements well in advance of the crop season.

(vi) State Government have been asked to implement the scheme on ground. Utilize the funds available with them and seek funds after complying with DoE' instructions."

Unified Farmer Service Interface (UFSI)

1.36 On the query as to how the Department plans to enhance the usage of Unified Farmer Service Interface(UFSI) especially with reference to vernacular languages and cutting edge technologies for widespread dissemination of information across various stakeholders be it public or private and especially in remote /backward regions of the country, the Department submitted as under :-

"Unified Farmer Service Interface (UFSI) is the foundational block of Agri Stack that enables interoperability of the various IT systems and databases in the Agriculture ecosystem. It comprises of a centrally defined data schema, definitions of set of APIs, and associated rules, call sequences and error codes. The same has been explained below:-

The UFSI comprises of the following:

(i) A centrally defined data schema for the registries, directories, master databases, and transactional data within Agri Stack. These will help to standardize the vocabulary across the agricultural services value-chain, and will form the basis of the data formats that will enable the interoperability

(ii) **Definitions of a set of APIs** to (a) access data in various databases pertaining to agriculture and (b) to support various use-cases across the agriculture value chain. These APIs may further be grouped together based on their relevance to various categories of use-cases (e.g., access to finance, access to inputs, access to markets, access to advice, access to agricultural services, etc.) (iii) Associated rules, call sequences and error codes for these APIs UFSI will enable sharing of data pertaining to agriculture and farmers between:

- States and the Ministry of Agriculture
- State Agriculture Departments and various Private sector entities
- State Agriculture Departments and other State Departments that have / need to use data pertaining to agriculture

• Ministry of Agriculture and other Central Ministries relating to a Farmer or to Agriculture

- Ministry of Agriculture and various private sector entities
- Banks, NBFCs and the government for limited parts of their agricultural loan processes
- Banks, NBFCs and other Banks, NBFCs for sharing data pertaining to agricultural loans availed of by individual farmers

• Private Sector entities and other private sector entities (for other agriculturerelated services) Where UFSI to start with will be defined with a limited focus on the 3 core registries being currently created at a national level, i.e., Farmer, Geo-Referenced Village Maps, and Crops sown. This will enable various usecases from the data available in these registries.

For example, it is expected that Banks via JanSamarth will be able to use these registries through UFSI to make the process of getting a Kisan Credit Card easier – (presence-less and paper-less) – for the farmer. A few other limited use-cases will also be addressed in UFSI 1.0.

The Architecture/Design of UFSI is such that as more use-cases become expected to be addressed, more datasets will need to be added to Agri Stack. UFSI will be expanded to cover those datasets over time, and accordingly potentially more types of users may end up using it as well."

NATIONAL AGRICULTURE MARKET(E-NAM) SCHEME

1.37 On the query as to how the Department plan or strategize to ensure that agri-value chain actors come under a single roof or unified structure and access the pool / basket of products and services at e-NAM and the steps taken to empower e-NAM to gain

considerable traction and transparency in the agricultural trade by integrating all APMCs and the time frame proposed to do so, the Department submitted as under :-

"e-NAM, as virtual market platform since its launch in April, 2016, is being regularly upgraded in terms of new technology, innovation, improving transparency in transactions, digital payments and user friendly features, etc. Opposed to the traditional system of marketing , e-NAM platform through launch of Platform of Platforms (PoPs) in July, 2022 as holistic unified structure is providing single roof for all value chain actors like farmers, FPOs, e-platform service providers, transport service providers, quality assaying service providers, value addition, processors, exporters, Fintech, storage, etc. So far, 71 service platforms have been empaneled under the following 10 service categories on PoP module i.e. Quality Assaying, Transportation, Warehousing, Fin-tech, Trading platforms, Agri advisory, Market information, Institutional buyers, Sorting and grading and Agri input aggregators. To facilitate transaction of agri commodities on e-NAM portal in a transparent manner, 1260 mandis of 22 States and 3 UTs have been integrated."

1.38 On being asked as to how the Department plan to transform the agriculture market into a phygital structure by promotion of disruptive technology innovations to provide a value architecture to the diverse agri-food chain actors and integrate the same with Global Value Chains(GVCs) and details of incentive schemes, if any, being provided to promote usage of e-NAM may please be provided, the Department submitted as under :-.

"Agriculture marketing is a state subject and over the years organized wholesale marketing is being carried out through the network of physical markets in the name of regulated markets. Government has already not only envisioned to use technology and innovations to bridge these physical markets in the form of phygital structure but it is being executed at the field level. Farmers and other market participants are getting due benefit of this phygital structure. Promotion of reforms linked to e-NAM and other such e-trading platforms/ e-market places in the private sector is the empirical evidence that Government's planning is in the right direction. Government has also been pursuing reforms towards this. The disruptive technology innovations in Agri Marketing space are not only providing value architecture but also altering the habit and attitude of agri food chain actors, farmers, FPOs, traders, processors, agro-industries to integrate with the Global Agri Value Chain. Government of India is providing Rs. 75 lakh grant per e-NAM mandi for infrastructure/ facility,

assaying labs, grading, packing facility and garbage disposal system. States are also providing various incentives to promote usage of e-NAM like reduction of market fee, prize on e-NAM trading, etc."

CLIMATE-SMART FARMING PRACTICES

1.39 When being asked by the Committee regarding the facilities provided to Small and Marginalized Farmers to remotely monitor their crops using sensors such as drones and satellites and the measures taken to make these services cost effective along with the impact of these technological advancements to increase yields of agricultural produce in backward, drought and flood prone regions of the country, the Department stated as under:-

"The Department of Agriculture and Farmers Welfare (DA&FW) is promoting adoption of Kisan Drones by the farmers for application of pesticides and crop nutrient. Standard Operating Procedures (SOPs) which provide concise instructions for effective and safe operations of drones for pesticide and nutrient application have been released. Financial assistance is also provided under Agricultural Mechanization as per the details given as under:

(i) Financial assistance @ 100% of the cost of drone up to a maximum of Rs. 10 lakhs per drone is provided for purchase of drones by institutes under Indian Council of Agricultural Research, Krishi Vigyan Kendras (KVKs), State Agriculture Universities (SAUs), State and other Central Government Agricultural Institutions/Departments and Public Sector Undertakings (PSUs) of Government of India engaged in agricultural activities. The Farmers Producers Organizations (FPOs) are provided grants up to 75% of the cost of agriculture drone for its demonstrations on the farmers' fields. A contingency expenditure of Rs.6000 per hectare is provided to implementing agencies that do not want to purchase drones but will hire drones for demonstrations from Custom Hiring Centres, Hi-tech Hubs, Drone Manufacturers and Start-Ups. The contingent expenditure to implementing agencies that purchases drones for drone demonstrations is limited to Rs.3000 per hectare.

(ii) In order to make available drone services to farmers on rental basis, financial assistance @ 40% up to a maximum of Rs. 4.00 lakhs are provided for purchase of drones by Custom Hiring Centers (CHCs) under Cooperative Society of Farmers,

FPOs and Rural entrepreneurs. Agriculture graduates establishing CHCs are eligible to receive financial assistance @ 50% of the cost of drone up to a maximum of Rs.5.00 lakhs per drone.

(iii) For individual purchase of drones, the Small and Marginal, Scheduled Caste/Scheduled Tribe, Women and North Eastern State farmers are provided financial assistance @ 50% of the cost up to a maximum of Rs. 5.00 lakhs and other farmers @ 40% up to a maximum of Rs. 4.00 lakhs.

Based on the proposals received so far, the funds amounting to Rs. 126.99 Crore have been released towards Kisan Drone promotion in 2022-23, which include Rs. 52.50 Crore released to the ICAR for purchase of 300 Kisan Drones and organizing their demonstrations on the farmers' fields in 75000 hectares through 100 KVKs, 75 ICAR institutions and 25 SAUs. It also includes funds released to various State Governments for supply of more than 300 Kisan Drone to farmers on subsidy and establishment of more than 1500 Kisan Drone CHCs to provide drone services to the farmers."

1.40 When asked by the Committee to provide list of schemes initiated to train farmers in Artificial Intelligence powered Chatbots &Virtual Assistants and other automated processes in agriculture to promote Climate Smart Farming and to state the role of agritech startups, if any, in Purple revolution and Aroma Mission and the plans of the development to replicate in other parts of the country, the Department submitted as under:-

"Due to low exposure of the various State Agriculture department in emerging technologies, the Department is enabling the implementation of emerging technologies in Agriculture sector through National e-Governance Plan in Agriculture (NeGPA). The NeGPA scheme drives implementation of Pilot Projects/Proof of Concepts(PoCs) involving the use of emerging technologies such as Artificial Intelligence & Machine Learning, Block Chain Technology, Internet of Things, Robotics etc. by the State Governments.

The result of such PoCs in the States is development and implementation of statelevel projects that utilize the emerging technologies for the growth of the agriculture sector. In these pilot projects, various farmers are exposed to these emerging technologies and they learn and benefit from them."

CHAPTER- II SCHEME-WISE ANALYSIS

Scheme-Wise Analysis of Central Sector Schemes followed by Scheme-wise Analysis of Centrally Sponsored Scheme being implemented by the Department in the light of Detailed Demands for Grants 2023-24 have been analysed in this Chapter

Pradhan Mantri Kisan Samman Nidhi (PM-KISAN)

2.2 The Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Scheme was approved by the Union Cabinet in its meeting held on 1.2.2019. It was inaugurated by the Hon'ble Prime Minister at national level in a function held on 24th February, 2019 at Gorakhpur (UP). The Scheme has been made effective from 01-12-2019. Under the Scheme, income support is provided to all eligible farmer families irrespective of the size of the cultivable land holding, by way of payment of Rs.6000/- per year, subject to certain exclusions. The financial benefit under the scheme is released in three 4-monthly installments of Rs.2000/- each over the year, to be credited into the bank accounts of the beneficiaries held in destination banks through Direct Benefit Transfer.

When asked by the Committee to provide details of Financial Performance of the Scheme, the Department submitted:-

2.3 When the Committee asked as to whether Department plans to link enhancement in inflation to PM-KISAN SAMMAN NIdhi as five years have passed since the Scheme was launched, the Department stated that as of now there is no plan to link enhancement in inflation to release of payments under the Scheme.

Pradhan Mantri Fasal Bima Yojana (PMFBY)

2.4 The objective of launching the new scheme, Pradhan Mantri Fasal Bima Yojana (PMFBY), a yield based scheme, and a weather index based 'Restructured Weather Based Crop Insurance Scheme (RWBCIS)' from Kharif 2016, is to provide a simple and affordable crop insurance product to ensure comprehensive risk cover for crops of farmers against all non-preventable natural risks from pre-sowing to post-harvest, to provide adequate claim amount and timely settlement of claims. The schemes' implementation is reviewed/monitored constantly through weekly video conferences, one to one meetings with the stakeholders on regular basis and the National Level Monitoring Committee (NLMC). Learning from the Scheme implementation experience, an extensive consultative exercise with all implementing partners was made and Operational Guidelines (OGs) of PMFBY/RWBCIS were revised with effect from 1st October, 2018 i.e. from Rabi 2018-19 season and revemaped w.e.f. Kharif 2020 season. Revamped operational guidelines are available on National Crop Insurance Portal i.e. <u>https://pmfby.gov.in/guidelines</u> for use of stakeholders under the scheme.

The Financial Performance/release of funds by Central Government under the PMFBY is stated to be:

2.5 The Committee further asked to furnish year-wise, State and Union territory-wise details of allocations made, RE, AE, Shortfall/Excess, if any, along with the reasons for the same, under the Scheme since 2019-20. The Department has submitted:-

"The Scheme is demand driven and voluntary for the States as well as farmers. Further, being a Central Sector Scheme, State/UT-wise allocation/release is not made under the scheme. The requisite Central share of premium subsidy to farmers is released to the Central Fund Routing Agency namely, Agriculture Insurance Company of India Ltd. (AIC), who in turn releases the fund to the implementing insurance companies as per coverage data entered on National Crop Insurance Portal (NCIP) on the receipt of respective State Government's requisite share in premium subsidy."

2.6 On specifically asked how the Department will manage to implement PMFBY Scheme in wake of increasing extreme weather conditions across the country with less allocation as it is a Flagship Scheme of the Department, the Department has submitted:

"The scheme is demand driven. Department has made various technological interventions like YESTECH(Yield Estimation System Based on Technology), WINDS(Weather Information Network and Data System), CROPIC (Collection of Real Time Photos and Observations of Crops) to incorporate weather and other natural parameter related information in implementation of the scheme. Based on the coverage under the scheme, additional funds, if required, may be sought at Revised Estimates 2023-24 Stage."

2.7 On being questioned as to whether representations/suggestions regarding PMFBY scheme have been received from the states & the stand taken by the Department in regard to the same and also as to whether the Department plans to incorporate best

practices from other models of State Govts. of similar schemes, the Department submitted as under:-

"Receipt of representations/suggestions from various stakeholders including States and improvements/revisions/revamping of the scheme is continuous process. As a result, after detailed discussions with the stakeholder, Pradhan Mantri Fasal Bima Yojana (PMFBY) has been introduced from Kharif 2016 season replacing the erstwhile crop insurance schemes. Various new improvements including reduction in unit area of insurance to Gram/Gram Panchayat level, change in method for calculation of threshold yield etc. were made under PMFBY. Further, based on the experience gained, views of various stakeholders and with a view to ensure better transparency, accountability, timely payment of claims to the farmers and to make the scheme more farmer friendly, Government has comprehensively revised and revamped the Operational Guidelines of the PMFBY with effect from Rabi 2018 and Kharif 2020 respectively to ensure the targeted delivery of benefits of the scheme to the farmers adequately and timely. "

2.8 What are the financial constraints being faced in implementation of PMFBY. Please enumerate steps/measures taken to ensure timely settlements of insurance claims made by the farmers. What is the prescribed time limit for redressal of grievances and how does it compare with the global standards. Please provide percentage of unsettled claims and the assistance provided in such cases to the distressed farmers.

"Major financial constraint in implementation of the scheme is delay/nonrelease of their share by the States. Admissible claims under the PMFBY are generally paid by the concerned insurance companies within two months of completion of Crop Cutting Experiments (CCEs)/harvesting period and one month of notification for invoking the risks/perils of prevented sowing, mid-season adversity and post-harvest losses subject to receipt of total share of premium subsidy from concerned Government within time. However, in a few cases settlement of claims in some States got delayed due to reasons like delayed transmission of yield data by States; late release of State share in premium subsidy, yield related disputes between insurance companies and States, nonreceipt of account details of some farmers for transfer of claims to the bank account of eligible farmers and National Electronic Fund Transfer (NEFT) related issues, erroneous/incomplete entry of individual farmers data on National Crop Insurance Portal (NCIP), delay or non-remittance in remittance of farmers share of premium to concerned insurance company etc.

The major work relating to the assessment of crop yield/crop loss for calculation of admissible claims are being performed by the concerned State Government or Joint Committee of State Government officials and concerned insurance company.

The PMFBY envisages infusion of improved technology in the implementation of the scheme. Accordingly YESTECH, WINDS, CROPIC etc. would help in timely settlement of claims. To bring more transparency in calculation of claims, results of CCEs are required to be uploaded on the National Crop Insurance Portal (NCIP).

Further, the insurance companies have also been allowed to witness the conduct of CCEs. As per provisions of the CCEs manual and PMFBY results of the CCEs are required to be noted on the prescribed form with the signature of the concerned officers conducting the CCEs and the farmers and officers of insurance companies witnessing the CCEs.

To sort out the grievances of insured farmers and other stakeholders, stratified grievance mechanism has been provided in the Revised/Revamped Operational Guideliens of the Scheme. At the initial level, for grievance redressal, each block & district have designated block/district level grievance redressal officer to respond to the grievances of Farmers, Banks, ICs etc. within 7 days of receipt of grievance. In case of dissatisfaction at block level the matter can be brought before District Level Grievance Redressal Committee (DGRC). DGRC is headed by District Magistrate/Collector and representatives of Farmers, LDM/Banks, DDM NABARD, Insurance Company and concerned District Authority/Department shall be appointed as members. This Committee may also invite subject specialists/experts from University / IMD/commodity Boards/Research Institutions, SRSC etc. if deemed necessary.

In case of disagreement with the decision by any party at district level; the same is represented to the State Level Grievance Redressal Committee (SGRC) within 15 days from the decision of DGRC. SGRC is headed by Principal Secretary/Secretary of Nodal Department, SLBC/Banks, CGM NABARD, Insurance Company and concerned State Authority/Department shall be appointed as members. This Committee may also invite subject specialists/experts from University/IMD/research institutions/commodity Boards/, State Remote Sensing Agency, STSU, STAC etc. if deemed necessary.

The SGRC has to dispose the grievance within 15 days time of receipt of grievance. The decision of the Committee shall be accepted by all the parties.

To better resolve all the grievances within the scheme, a Centralized Farmers Grievance Redressal portal has been developed to handle all grievances from end to end. It is equipped with the necessary features viz., Complaint/Query capturing through multiple modes, farmer authentication & online ticket forwarding to the concerned company, online escalation as per escalation matrices, updating of resolution details, MIS & Dashboards for data analysis. The Portal captures the details of the grievances and then forwards it to the concerned Insurance Company for resolution. It has API based connectivity to the insurance companies so that the farmer can directly have access to all information from the portal rather than obtaining the same from the Insurance Companies. The system has been well designed ensuring that every grievance is taken to logical conclusion to the satisfaction of the farmer. Every grievance will have a Ticket ID with ticket closure responsibility lying with the Insurance Company with defined turnaround time."

Modified Interest Subvention Scheme (MISS)

2.9 The Interest Subvention Scheme (ISS), Central Sector Scheme, 100% funded by Government of India, was launched in the year 2006-07 with a view to provide short term Agri-loans availed by farmers through KCC for their working capital requirements at concessional rate of interest. The scheme has been renamed as Modified Interest Subvention Scheme(MISS) from the year 2021-22. Under this scheme, farmers are given Kisan Credit-I Card(KCC) loan at subvented interest rate of 7%. For this, at present, interest subvention(IS) of @1.5% is being given to financial institutions. Therefore, short term loans for Agriculture and other allied activities including animal husbandry, dairy, fisheries etc. upto Rs. 3 lakh is available to farmers at an interest rate of 7% per annum. Additional 3% subvention is also given to the farmers for prompt and timely repayment of loans; thus reducing the effective rate of interest to 4% per annum. In case of short term loan availed for allied activities only(other than crop husbandry), the loan amount upto Rs. 2 lakh is available at the rate of 7%. Additional 3% interest subvention is also available on it.

2.10 When asked to furnish Financial Performance of the MIS Scheme, the Department submitted as under :

- With the objective of protecting the Small and Marginal Farmers (SMFs) against distress sale of their
 produce, the benefit of IS is available for post-harvest loans against Negotiable Warehouse Receipts
 (NWRs) which is given at par with the interest subvention on crop loans for a further period of six
 months post-harvest to SMFs having Kisan Credit-I Cards (KCCs).
- In order to provide relief to the farmers on occurrence of natural calamities, the component of
 interest subvention is available on the restructured amount to banks for the first year and such
 restructured loans would attract normal rate of interest from the second year onwards as per the
 policy laid down by RBI.
- Interest subvention and prompt repayment incentive on restructured crop loans is also given to farmers affected by severe natural calamities for a maximum period of 5 years on the basis of report of Inter-Ministerial Central Team (IMCT) for grant of NDRF assistance and Sub-Committee of National Executive Committee (SC-NEC)."

2.11 On being asked to furnish year-wise, State and Union territory-wise details of allocations made, RE, AE, Physical Performance, Targets, Targets Achieved, Shortfall/Excess, if any, along with the reasons for the same, under the Scheme/Programme being implemented by the Department since 2019-20, the Department has submitted:

"The implementing agencies for settling the claims under Modified Interest Subvention Scheme are Reserve Bank of India (RBI)/National Bank for Agriculture and Rural development (NABARD) to which funds are released for further disbursement to Scheduled Commercial Banks (SCBs)/ Small Finance Banks / RRBs/ Cooperatives/ Computerized PACS ceded with SCBs. There is no State and Union territory-wise details of Physical Performance, Targets Set, Targets Achieved, Shortfall/ Excess for the MISS."

2.13 When asked to furnish State and Union territory wise details of Physical Performance, Targets Set, Targets achieved, Shortfall/Excess, if any for the Scheme being implemented, the Department stated as under :

"Under Price Support Scheme (PSS), the procurement of notified pulses, oilseeds & copra is undertaken by way of intervening the market through designated Central Nodal agencies, as and when the market price of these commodities falls below the notified Minimum Support Price (MSP) in order to provide remunerative price to the farmers and to protect them from distress sale . Similarly, under Market Intervention Scheme (MIS), the procurement of perishable agriculture and horticulture crops for which MSP is not announced is undertaken by way of intervening the market through State designated procuring agencies in order to provide remunerative price to the farmers and to protect them from distress sales. Since MIS & PSS are market driven schemes, the physical targets cannot be set in advance."

2.14 On the query of the Committee as to how the Department intends to proceed ahead and fulfill its requirements given the fact that only Rs. 1 lakh for Market Intervention/Price Support Scheme in BE 2023-24 has been allocated in comparison to Rs 1500 Crore in the last Budget, the Department stated as under:-

"Under PSS, Government has provided Government Guarantee amounting to Rs. 40,500 cr. for extending cash credit facilities to Central Nodal Agencies (i.e. NAFED - Rs.39,000 crore & FCI – Rs. 1,500 crore) for procurement of pulses, oilseeds & copra at Minimum Support Price (MSP). Central Nodal Agencies withdraw the required funds against the Government Guarantee for making payment of MSP value to farmers and other incidental costs involved in the PSS operations. The provisions of budgetary funds are meant for meeting any losses incurred in the undertaking of such operations. The indicative budgetary estimates are based on previous years demand of the schemes and get revised as per the actual requirement. Any additional demand/ requirement of funds can be provided for at RE stage. Hence, the implementation of PSS-MIS does not get hampered due to budget."

DISTRIBUTION OF PULSES TO STATE/UNION TERRITORIES FOR WELFARE SCHEME

2.15 This scheme envisages direct payment of the difference between the MSP and the selling / modal price to pre- registered farmers selling oilseeds of prescribed Fair Average Quality (FAQ) norms within the stipulated period in the notified market yard through a transparent auction process. All the payments will be done directly into the bank account of farmers. This scheme does not involve any physical procurement. Under PDPS full compensation of difference between MSP and Sale/Modal price i.e. Price Deficiency, received by farmers upto 25% of MSP value (including 2% administrative cost) will be borne by Central Government. The support of the central government will be given for quantity upto 25% of production. If any State is willing to cover quantities beyond 25%, the same needs to be funded from the resources of State Governments.

Distribution of Pulses to State / Union Territories For Welfare Scheme

2.17 On being asked by the Committee to provide the details/proposed strategy as to how the Department plans to spend the funds allocated for the Scheme, the Department submitted as under :

"The funds allocated under the scheme will be utilized for reimbursement of discounted subsidy to implementing agency based on actual demand of pulses from States/ lifting of stocks by States and certification by implementing agency to this extent. Monitoring of implementation is being done through an Empowered Committee headed by Additional Secretary to ensure lifting of all stock and optimum utilization of funds."

Formation and Promotion of Farmers Producer Organization (FPOs)

2.18 Objective of the Scheme is as follows:

• To provide holistic and broad based supportive ecosystem to form new 10,000 FPOs to facilitate development of vibrant and sustainable income oriented farming and for overall socio-economic development and wellbeing of agrarian communities.

• To enhance productivity through efficient, cost-effective and sustainable resource use and realize higher returns through better liquidity and market linkages for their produce and become sustainable through collective action.

• To provide handholding and support to new FPOs up to 5 years from the year of creation in all aspects of management of FPO, inputs, production, processing and value addition, market linkages, credit linkages and use of technology etc.

2.19 When asked to furnish Financial Performance of the Scheme being implemented by the Department, the Department has submitted:

2.20 On being asked to as to how the Department plan to utilize higher allocated funds during the year 2023-24 since the focus of the Government is to enhance cost effective productivity and higher net incomes to the member farmer producers group, the Department submitted as under :-

"As on 31.01.2023, 4601 FPOs have been registered under 10,000 FPOs scheme and equity grant have been released to 1951 FPOs. Implementing Agencies are closely and cohesively working with Cluster Based Business Organisations (CBBOs) to ensure that CBBOs perform their activities to make FPOs economically sustainable. The Formation and Incubation cost of CBBO, limited to maximum of Rs. 25 lakh / FPO for five years from the year of formation. FPO Management Cost of Rs. 18 lakh per FPO will be provided to FPOs towards salary of staff, registration of FPO, office rent and utility charges, minor equipment cost, travel & misc. expenses etc. 10,000 FPOs will be formed by Implementing Agencies by FY 2023-24. This will accelerate the utilization of the funds.

FPOs will be working on the value addition, processing, and marketing of the agri produce. This will ensure remunerative prices of the value-added products and will improve the income of the members."

2.21 On being further asked as to how does the Department intend to implement the scheme effectively across the country, the Department submitted as under:-

"Following interventions were taken by the department to implement the scheme effectively across the country: -

- a) Through pro-active review and monitoring mechanism, Department is keeping track on the activities of FPOs.
- b) Implementing Agencies are responsible for effective implementation of the scheme.
- c) Survey and monitoring is being conducted through attached offices, who will visit the FPO premises.
- d) National Project Management Agency is engaged for effective coordination amongst various stakeholders.
- e) Learning Management System (LMS) is being formed under the scheme to track the progress of training by various stakeholders.
- f) An integrated portal is being made for data management and MIS."

BHARATIYA PRAKRITIK KRISHI BIO-INPUT RESOURCE CENTERS

2.22 In the Budget Speech (2023-2024), it has been stated that to facilitate the adoption of National Farming the Government Plan to setup, 10,000 Bio-Input Resource Centres, creating a national level distributed Micro-fertilizer and pesticide manufacturing network. *For a Centrally Sponsored Scheme that is, National Mission of Natural Farming* (NMNF) *an Allocation of Rs.459 crore has been made in the Budget of 2023-24.*

2.23 On being asked by the Committee regarding the Action Plan being chalked out by the Department w.r.t. National Mission on Natural Farming(NMNF) and Salient Features of the Mission, the Department submitted as under :-

"In tune with the Budget Announcement the DA&FW has included the setting up of 15,000 Bio-Input resource centers as a part of cluster development activities under NMNF.

Under NMNF it is proposed to develop 50 ha model clusters for Natural Farming at block level with an allocation of Rs 12.45 lakh per clusters out of which, 7.5 lakh have been earmarked for on farm input production including Micro fertilizer from cattle dung and urine and plant extract based pesticides. The scheme is awaiting cabinet approval.

Salient features of National Mission on Natural Farming

Natural Farming is a chemical-free traditional farming based on sound agro-ecology with a focus on diversity on farm and in cropping systems, soil enrichment through cow dung-urine based microbial formulations, biomass recycling through mulching and plant protection through diversity and botanical concoctions. Natural farming as a principal excludes all purchased inputs.

Need and relevance of National Mission on Natural Farming -

 Green revolution no doubt transformed the agriculture from subsistence to surplus generating enterprise, but indiscriminate use of chemical agro inputs led to depletion of resources, deteriorating soil health, environmental degradation and chemical residues in food chain. Such issues call for a paradigm shift towards Agroecological practices which are environment friendly, non-degrading, sustainable and promises safe and healthy food

- Potential and benefits Natural farming systems developed over years by farmers ensure comparable productivity, reduction in cost of cultivation, enhanced biodiversity, resource conservation and safe and healthy food. As per some success stories compiled by NITI Ayog, natural farming promises up to 12% increase in productivity, 25% reduction in cost and substantial increase in profitability.
- Promotion of Natural Farming DA&FW is promoting natural farming through "Bhartiya Prakratik Krishi Paddhati a sub-scheme of PKVY since 2019-20 and sanctioned 4.09 lakh ha area under 8 states. Keeping the response and enthusiasm, the BPKP is now being up scaled as "National Mission on Natural Farming".
- Natural Farming (Bhartiya Prakratik Krishi Paddhati (NF-BPKP) is a way of chemical free farming based on desi-cow and locally available resources, with no chemical fertilizers and pesticides and rooted in Indian tradition. NF-BPKP is aimed at promoting traditional indigenous practices which gives freedom to farmers from externally purchased inputs and is largely based on on-farm biomass recycling with major stress on biomass mulching, use of on-farm desicow dung-urine formulations; maintaining soil aeration and exclusion of all synthetic chemical inputs directly or indirectly.
- National Mission on Natural Farming is proposed as mass movement program through continuous capacity building and handholding, demonstrating the benefits of natural farming through Champion farmers of natural farming and encouraging farmers to adopt the same willingly by their own.

Objectives of Mission

- Centrally sponsored scheme with central Govt outlay of Rs. 1584 crore
- Nation-wide outreach and training through central & State agencies.
- One Model Natural Farming cluster in at least one Gram Panchayat in each block.
- Farmer Field school (FFS) to be the key awareness strategy
- States to roll out Clusters in selected GPs.
- Clusters to be developed around a Champion farmer Each One Teach One

• Targets envisaged

- > 20,000 Farmer field schools to be conducted.
- > 15,000 clusters to be developed across the country.
- 750,000 ha area & 15 lakh farmers to be converted and equal number of Farmers to be trained – Each One Teach One.
- National Centre for Organic & Natural Farming (NCONF) to facilitate Certification & Training of Master trainers.
- ICAR has identified 425 KVKs to be model training and demonstration centres for NF.
- MANAGE designated as Knowledge partner for NF extension
- Focus is mainly on capacity building to create network of master trainers, champion farmers and support institutions for technology development and dissemination;
- Strategies of the implementation of National Mission on Natural Farming (NMNF):

Strategies include knowledge collection, dissemination, training, demonstration, handholding and continuous capacity building of the farmers. Mission Implementation shall focus on following activities:

- Lead States like Andhra Pradesh, Gujarat & Himachal Pradesh will form the foundation for rollout of the scheme.
- State missions Focus will be on capacity building of mission officers through trainings and exposure visits and interaction with best practitioners
- Individual NF Practitioner: Practicing natural farmers will function as the knowledge demonstration hubs where practical learning will take place.
- Documentation of Best Practices: Best practices will be documented and disseminated
- Farm Field Schools (FFS) Capacity building through Farm Field School
- Development of clusters Willing farmers to be registered for formation of clusters
- Certification and market linkages NF clusters will be certified under farmer centric, local verification-based certification system.
- Institutional Intervention: -Institutional intervention is a major component for driving the Mission. Institute of Agricultural Extension Management (MANAGE) has

been functioning as a knowledge partner for extension and capacity building while National Centre for Organic and Natural Farming (NCONF) is entrusted for Certification and training"

2.24 The Department further stated

1) "The BPKP scheme is being up scaled in Mission Mode as a separate as National Mission on Natural Farming to cover 7.5 lakh ha area by developing 15000 clusters

2) Pre-launch initiative undertaken to promote Natural Framing

The Government initiative undertaken to promote natural farming

a. National Institute of Agricultural Extension Management (MANAGE) designated as national level "Knowledge partner for extension" with State Agriculture Management Extension Training Institutes (SAMETIs) as state branches have accomplished:-

4) Tentative area allocation to States have been communicated and requested for submission of Annual Action Plan for 2023-24."

DIGITAL PUBLIC INFRASTRUCTURE FOR AGRICULTURE

2.25 In the Budget Speech of 2023-2024, the Finance Minister has announced that Digital Public Infrastructure for Agriculture will be built as an open source, open standard and inter operable public good. This will enable inclusive, farmer-centric solutions through relevant information services for crop planning and health, improved access to farm inputs, Credit-I, and insurance, help for crop estimation, market intelligence, and support for growth of Agri-tech industry and start-ups.

2.26 On being asked by the Committee regarding the expected time by which the Digital Public Infrastructure for Agriculture will be built alongwith complete details, the Department submitted as under :-

"The Digital Public Infrastructure for Agriculture, i.e., Agri Stack is envisioned to be implemented in a phased manner with the first phase roll-out in March 2023. The work around several components is planned to be initiated and completed in alignment with overall priority and dependency across activities.

Part II

OBSERVATIONS/ RECOMMENDATIONS

ANALYSIS OF DEMANDS FOR GRANTS-DEMAND NO.1

1. The Committee note that the Department of Agriculture and Farmers Welfare has been allocated Rs.110531.79 Crore for 2023-24 at BE Stage, which is 4.56% more than RE of Rs.110254.53 Crore for 2022-23. The actual utilization of funds for 2022-23 (as on 27.01.2023), w.r.t. RE stands at 58.78%, which suggests that the Department needs to strive hard to fully utilize the funds in remaining period of one month or more of 2022-23 which seem to be an arduous task. The Committee feel that the Budget Estimate is a better source to compare with the Actual Expenditure rather than the Revised Estimate. Moreover, the Department has not been able to stick to its Monthly Expenditure Plan during 2022-23 so far. The Committee are of the considered opinion that the Department should strive hard to ensure optimum utilization of the allocated RE funds by sticking to the Monthly/Quarterly Expenditure Plan in consonance with the guidelines issued by the Department of Expenditure, Ministry of Finance from time to time. They feel any rush of expenditure in the last quarter of the year should invariably be avoided at all costs.

2. The Committee note that the Department has admitted in its replies that the proportion of Budgetary Allocations made in favour of the Department in terms of the percentage out of the total budget of the Government of India during the years 2020-21, 2021-22, 2022-23 and 2023-24 stood at 4.41%, 3.53%, 3.14 % and 2.57% respectively. The total Budget outlay of the Central Government in 2020-21 was Rs. 30,42,230.09 Crore, which increased to Rs. 45,03,097.45 Crore in 2023-24. Taking into account the prominent role played by Agriculture in rural livelihood,

, ,

employment generation and food security of the country, the Committee recommend the Department to take up the issue of budgetary allocation in percentage terms out of Central Pool with the Ministry of Finance and ensure that trend is reversed from the next Budget onwards.

3. The Committee note that while replying to its concern about utilization of funds during 2022-23, the Department has submitted that taking into account the proposals in the pipeline, the Department is likely to utilise the entire Budget during the current FY 2022-23, except the quota allocated under mandatory provision for NE States where the utilisation is restricted on account of low cultivable area, nonrelease of matching share by those States and community landholding. This, in turn, clearly indicates that the Department has admitted that it will not be able to fully utilize the funds allocated to it even before the close of Financial Year 2022-23. The Committee are of the considered view that since the Department is aware of the reasons/factors, which hamper cent percent utilization of funds available, it should suitably modify its Schemes including the funding pattern as well as method of implementation, so that effective and optimal utilization of funds earmarked for Agriculture Sector can be ensured. The Committee feel that there are two major Crop seasons - Kharif and Rabi. The Department should consider the release of funds for Centrally Sponsored Schemes in two instalments of 50 percent each as was being done in the past instead of the present scheme of four equal instalments of 25% each, would reduce the time lag in implementation of the Schemes, reduce documentation time and will enable expeditious payments. The Committee feel that the Department may take up the matter with the Department of Expenditure for suitable modification of the existing guidelines in view of the fact that Agriculture is

a State subject. The Committee would like to be apprised of the steps taken in this regard.

FUNDS SURRENDERED BY THE DEPARTMENT

4. The Committee note from the reply of the Department that funds have been surrendered amounting to Rs. 23,824.54 Crore, Rs. 429.22 Crore and Rs.19,762.05 Crore during 2020-21, 2021-22 and 2022-23(Tentative) respectively. That means Rs. 44,015.81 Crore in total have been surrendered by the Department in these years. The Committee have been informed that the surrender of funds is mainly on account of less requirement under NES (North Eastern States), SCSP (Schedule Caste Sub-Plan) and Tribal Area Sub-Plan (TASP) Components. The Committee feel that the practice of surrender of funds must be avoided by all means henceforth so that the tangible benefits accrued from the Schemes are allowed to percolate to the ground level in an optimum manner. The Committee, therefore, recommend the Department to identify avoidable reasons leading to surrender of funds and take corrective measures to ensure that the funds are utilized fully and efficiently.

SUPPLEMENTARY DEMANDS FOR GRANTS OF THE DEPARTMENT

5. The Committee have been informed that the Department, on the one hand, has made provisions for the Supplementary Demands of Rs. 22,245.51 Crore during 2022-23 (tentative) and on the other, is surrendering funds not utilized by it amounting to Rs. 19762.05 Crore. The Committee are constrained to note that raising supplementary demands on one hand and surrender of funds on the other

are incompatible and reflects on the expenditure planning done by the Department. The Committee, therefore, desire the Department to undertake the planning of utilization of allocated funds seriously and ensure expenditure of the funds in the planned and stipulated manner. The Committee are of the considered opinion that sticking to implementing Monthly Expenditure Plan/Quarterly Expenditure Plan (MEP/QEP) in respect of Central Sector Schemes will go a long way in solving the problem of surrender of funds as well as raising Supplementary Demands.

STATUS OF UTILIZATION CERTIFICATES (UCs)

The Committee note that the amount of Utilization Certificate (UCs) pending 6. with States and Union territories has shown an increase over the years between 2016-17 and 2021-22. The Committee have noted that Rs 5926.72 Crore is pending as on 30.12.2022 for the releases upto 2020-21, which depicts that the monitoring mechanism needs to be revamped and strengthened. The Committee feel that the increasing pendency of UCs is acting as a bottleneck in smooth implementation of the Centrally Sponsored Programmes/Schemes run by the Department as pending UCs deprive Nodal Agencies/States/Union Territories in getting further funds. The Committee, therefore, recommend the Department to seriously look into the matter of increasing pendency of Utilization Certificates and take up the same with States / Union territories / Implementing Nodal Agencies by way of exploring innovative methods like Information Technology tools or Artificial Intelligence enabled software to utilize the allocated funds within stipulated time and furnish the UCs in time so that the farmers living in these States and Union territories are able to derive the real benefits of the Schemes at the ground level.

INCREASE IN FARMERS' INCOME

7. The Committee have been informed that increase in income of farmers is assessed on the basis of results of successful implementation of all the schemes and programmes of the Department. It has also been informed that apart from enhancement in budget allocation for agriculture sector, a number of schemes are being implemented which include Pradhan Mantri Fasal Bima Yojana, PM (KISAN) Yojana, Promotion of Farmers Producer Organizations, Institutional Credit for Agriculture Sector, etc. The Committee have further been informed that despite significant stress on government finance on account of recovery of pandemic induced shock, global economic scenario, etc., the allocation of funds for the Department is on the higher side as compared to many other Departments.

The Committee, while appreciating all the Schemes run by the Government to increase farmers' income, recommend the Department to ensure effective implementation of all the Schemes intended for the welfare of farmers so that the Schemes have a tangible effect on the ground level and the farmer's condition is improved in a significant way.

Scheme-wise Analysis of Demands for Grants 2023-24 and Recommendations of the Committee on some of the Important Programmes/Schemes being implemented by the Department.

PRADHAN MANTRI FASAL BIMA YOJNA (PMFBY)

8. A Budgetary Allocation of Rs.13625 Crore has been made for the implementation of the Pradhan Mantri Fasal Bima Yojna (PMFBY) for 2023-24 against the RE of Rs.12375.76 Crore for 2022-23. As regards the lower allocation for the Scheme in 2023-24, as compared to BE 2022-23 of Rs.15500 Crore, the Department of Agriculture and Farmers Welfare has stated that the Scheme is

demand driven and that based on the coverage and demand situation under the Scheme, additional funds, if required, may be sought at Revised Estimates 2023-24 Stage. The Committee recommend that the Department of Agriculture and Farmers Welfare should review the implementation of the Scheme at regular intervals to assess the demand situation and funds requirement for the Scheme.

The Committee desire that the Department look into the reasons for delay in settlement of claims by Insurance Companies and take necessary measures and make concerted efforts to address them in the best possible manner so that they are counted in best practices to be adopted globally and enhance the credibility of PMFBY among the Farmers manifold.

MODIFIED INTEREST SUBVENTION SCHEME

9. A budgetary provision of Rs.23000 Crore for 2023-24 has been made for the implementation of Modified Interest Subvention Scheme, a Central Sector Scheme, fully funded by the Government of India to provide concessional crop loans to farmers through Kisan Credit Cards (KCCs). The RE 2022-23 for the Scheme is Rs.22000 Crore. The Committee desire that Farmers who belong to Small or Marginalised sections including SC and Tribal Categories be provided adequate support to enable them to avail maximum benefits under the Scheme. Moreover, all Financial Institutions, be it Scheduled Commercial Banks, Small Finance Banks, etc., be advised regularly to disseminate the details of the Scheme, especially in remote / backward areas of the country so that the Farmers residing in these areas are able to avail the benefits of the Scheme. Moreover, third party audit of the Scheme needs to be done on a regular basis to know the shortcomings and also keep improving the Operational Guidelines on continued basis.

FORMATION AND PROMOTION OF FARMERS PRODUCER ORGANIZATION (FPOs)

10. The Committee have been informed that FPOs would be working on the value addition, processing and marketing of the agri-produce which in turn would ensure remunerative prices of the value-added products and consequently would improve the income of the members. The Committee feel that these FPOs would require professionals for their smooth functioning and hence capacity building programmes for the Office bearers of FPO may be conducted. Similarly, the members may be trained in adequate skills related to value addition, storage of agri - products and latest tools related to Information Technology. Appropriate linkages between Financial Institutions and FPOs be made for actual realisation of the benefits of the Scheme. The Committee recommend that timely inputs, skilled manpower & expertise be shared with FPOs so that these are successful in achieving their objective.

NATIONAL AGRICULTURE MARKET(e-NAM) SCHEME

11. The Committee have been informed that e-NAM, the virtual market platform since its launch in April, 2016, is being regularly upgraded in terms of new technology, innovation, improving transparency in transactions, digital payments and user friendly features. In July, 2022, e-NAM platform through launch of Platform of Platforms (PoPs) as holistic unified structure, has been providing single roof for all value chain actors like farmers, FPOs, e-platform service providers, transport service providers, quality assaying service providers, value addition, processors, exporters, Fintech, storage, etc. and service platforms have been empaneled under the following 10 service categories on PoP module i.e. Quality Assaying,

Transportation, Warehousing, Fin-tech, Trading platforms, Agri advisory, Market information, Institutional buyers, Sorting and grading and Agri input aggregators. The Committee desire that integration of all Mandis pan India with e-NAM platform must be done at the earliest so that online transaction of agri-commodities be done by the farmers even located at remote corners of the country to fetch good prices for their produce. Overall, this would result in a win-win situation for both the farmers and buyers.

SMART FARMING PRACTICES

12. The Committee have been informed that the Department has been promoting adoption of Kisan Drones by the farmers for application of pesticides and crop nutrient and Standard Operating Procedures(SOPs) containing concise instructions for effective and safe operations of drones for pesticide and nutrient application have been released. The Committee desire that Small and Marginalised Farmers including from SC/ST communities be provided adequate training in the latest technologies to enable them to harness the tangible benefits of this Scheme. The Committee also desire that the technological advancements in the field of Agriculture may be made available to farmers at affordable rates.

2. The Power point presentation covered the following main points :-

- (ii) Overview of Demands for Grants of DA&FW for 2022-23.
- (iii) Scheme-wise Demands for Grants 2023-24.

(iv) Implementation of (a) Pradhan Mantri Kisan Samman Nidhi Yojana (PM-KISAN)
(b) Pradhan Mantri Fasal Bima Yojana(PMFBY) (c) Modified Interest Subvention
Scheme (d) Formation & Promotion of 10,000 FPOs (e) Agriculture Infrastructure
Fund (f) Distribution of pulses to State/UTs for welfare schemes (g)
Rashtriya Krishi Vikas Yojana (RKVY) (h) Krishonnati Yojana (i) Digital Public

- (vi) Need to promote Traditional/Organic Farming Practices.
- (vii) Ensuring effective implementation of Rashtriya Krishi Vikas Yojana.
- (viii) Ensuring income protection to farmers to motivate them to shift to millets/coarse grains (*Shri Anna*).
- (ix) To promote FPOs effectively to facilitate farmers in fulfilling their requisite needs.
- (x) Ensuring effective implementation of 'Soil Health Card Scheme'.
- (xi) Ensuring Minimum Support Price(MSP) to farmers for their produce.
